
## **BUILDING USE AGREEMENT**

- The LESSEE agrees to erect the necessary tables and/or chairs and take down the same at the end of function. The LESSEE agrees to provide the necessary service to place the premises in the same condition prior to their lease.
- 2. Decorations shall only be placed on the designated panels/hooks. No decorations shall be hung from the ceiling or the walls. Decorations shall not include the use of: pins, tacks, nails, staples, putty or tape anywhere in the room, including the walls, floors and ceiling. All tables used will be covered with a plastic covering.
- 3. The **LESSEE** may use the walk-in cooler in the serving area to store cold items.
- 4. The **LESSEE** shall remove **all** articles and property brought upon the premises before the Agreement expires. NO parking will be permitted in areas so indicated (e.g. adjacent to the truck room doors).
- 5. The **LESSEE** shall be responsible for any injury or damage that may happen to any person(s) using the premises at the time of the rental.
- 6. It is expressly understood and agreed that the **LESSOR** is not responsible in any manner for any personal property or equipment that the **LESSEE** or any guest attending said function brings to the premises. All losses and damages from theft or otherwise to the premises or property of the **LESSOR** is entirely assumed by the **LESSEE**.
- 7. The **LESSEE** is not permitted to tamper with electrical, mechanical, heating and ventilating or other utilities within the premises other than normal lighting. Special requirements shall be identified by the **LESSEE** at the time this Agreement is made.
- 8. In the event of any damages, the **LESSEE** agrees to pay for any damages to the Hall or property of the **LESSOR** within 30 **days** from the date of the rental.

10.	Intoxicating beverages may be served where the function so dictates. The <b>LESSEE</b> shall not violate any of the Laws of the Commonwealth of Pennsylvania or Ordinances of the Borough of New Stanton. All beverages will be dispensed by agents of the <b>LESSOR</b> or <b>LESSEE</b> [if Lessee, fee reduced accordingly] and must remain within the premises. All guests may be asked to provide photo I.D. to be served and any visibly intoxicated person will not be served.		
11.	The bar will be open for a total of 5 hours, ending a.m./p.m Last call will announce 30 minutes before the scheduled end time with no service after that time.		
12.	Additional time for an open bar may be purchased for the price of \$50./hour, up to a maximum of 2 hours. This time must be scheduled and paid for in advance of the rental.		
13.	The <b>LESSOR</b> agrees to return the deposit fee, subject to negotiation on any damages to the Hall or property of the <b>LESSOR</b> , within 14 days from the date of the rental. In the

In the event of a cancellation, the <b>LESSEE</b> agrees to forfeit the deposit unless the <b>LESSOR</b> is able to schedule another event in its place before the date of the original function. The full rental fee must be paid by the <b>LESSEE</b> NO LATER THAN two [2] weeks before the function date. Security deposits WILL NOT be used to settle any Agreement debt.
