Concession (Cotton Candy Machine) Rental Agreement

This agreement is made between from The Candy Depot (Owner)

Renter shall pay The Candy Depot \$50.00 as a payment for the rental of Cotton Candy Machine. All payments are made in cash or card. 50% or \$25.00 needed at time of reservation to guarantee a time slot.

IF THE MACHINE IS DAMAGED IN ANY WAY YOU ARE TOTALLY RESPONSIBLE FOR THE EQUIPMENT.

- Renter will have the option of purchasing additional supplies for the Cotton Candy machine. Equipment has to be picked up the day prior to event during retail store hours. Equipment has to be returned on the day after the event during retail store hours unless special arrangements have been made between owner and renter.
- Equipment must only be used at the location on the contract. Payments must be made the day Equipment is picked up. The Candy Depot is not responsible for any injuries that may occur while machine is in operations. Renter must advise The Candy Depot immediately at (419-217-0346 or 419-217-984) if equipment has any difficulties, damages, or malfunctions. Renter is responsible for making electrical access for machine rental.

Cotton Candy machine must be cleaned up and wiped down prior to being returned if equipment is not cleaned a fee of \$25 will be incurred.

CANCELLATION:

This agreement cannot be cancelled, except in writing no later than 14 days prior to the event, by either the Client or The Candy Depot. If the Client initiates the cancellation, The Candy Depot will retain the non-refundable deposit paid at time of reservation. In the event of illness, injury, act of God or any other situation beyond the control of either the client or The Candy Depot cancellations will be voided. In the event The Candy Depot must cancel the reservation for any reason, Client will be entitled to full return of deposit, and agrees not to pursue any other damages against The Candy Depot or its owner resulting from the cancellation.

PROVISIONS:

The Candy Depot requires access to the desired set-up area at least 1 hour prior to the start time. In addition, 30 minutes are required after the conclusion of the service period to take down and removal. The Client is responsible for providing a sturdy, level table capable of supporting at least 150 pounds. The Candy Depot also requires at least 1 110-volt circuit within 10 feet of the desired set-up area that adheres to

contemporary safety standards and supplies at least 15 amps. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions. All instructions per use of the equipment must be followed; which includes warm up time for the equipment and resting time for the machine ;following a one hour use of equipment.

The Candy Depot reserves the right to use any pictures from the event in advertising. In the event that The Candy Depot cancels the contract, Client's deposit will be refunded immediately.

LIABILITY:

Client agrees to assume full responsibility and liability for any and all claims arising out of the use of the concessions or its attendants. The Candy Depot will not be held liable for any injury, allergic reaction, loss or damage directly or consequently arising out of the use or rental of the Concession Machines. Client will indemnify The Candy Depot against, and hold The Candy Depot harmless from all claims, actions, proceedings, costs, damages, and liability including attorney's fees, arising out of, in connections with, or resulting from the rental of The Candy Depot concession.

PAYMENT TERMS:

A 50% of your Total rental cost, non-refundable deposit is required to reserve a The Candy Depot concession machine. To confirm this agreement, return one signed and completed copy of this contract along with the deposit within 5 days of the reservation. In the event the signed contract is not returned, payment of the deposit shall be deemed full approval, acceptance and agreement to the terms and conditions contained in this contract. The balance is due NO LATER than 14 days prior to the event and can be paid in cash or by card. Once the balance is paid, no refund shall be made.

OPTIONAL:

Travel charges for events outside the Bellevue area. Travel fees will be listed in your invoice if they apply.
