Vendor Contract

The following guidelines have been established to maintain the integrity of the Greene County Youth Fair and to create a pleasant experience for all participants.

- Held rain or shine - NO refunds
- No vendor may sell food or beverage items sold at concessions
- No vendor may sell items considered weapons or dangerous to children.
 - No set-up until vehicle is unloaded and moved to parking area.
- All displays must stay within designated area and no debris may be visible.
- No soliciting, approaching patrons, or distribution of materials for anything other than what you are selling in your location.
- Booth set-up must take place prior to 8:30AM on any given day and break-down is not to take place until close of fair.
- All Vendors are responsible for safekeeping of their own booths and merchandise.
 - Lead cords must be 12-gauge wire.

The Greene County Agricultural Society reserves final approval on all issues. Please remember that this is a family friendly fair and display or sale items, photographs, or materials that are deemed inappropriate by the Greene County Agricultural Society may result in your dismissal from the fair at any time without refund.

Effort will be made to limit home-based franchised products to one vendor per franchise (on a first come, first served basis).
