V. Partners Reports:

NYSCDEA' Report: Caitlin Stewart, NYCDEA President gave updates on the Leadership Institute training set for July 18-21, 2023. The registration deadline has been extended to June 2nd. Caitlin extended an invitation to the NYACD Board and any Directors wishing to attend.

Caitlin reported on the fall Conservation Skills workshop, the March 2024 Water Quality Symposium, and the administrative training session set for this fall.

Caitlin expressed her thanks to everyone on another great NYS Envirothon. This year her staff person Katie WhitKovits was able to attend and be an oral presentation judge and she had a fabulous time at the event and wants to help again next year. Caitlin stated she hopes to help at the NYS Envirothon once again starting next year.

Caitlin reported that the 4-Way Partnership meeting will be held in May and the MOA was discussed and changes will be made. Caitlin shared once she has completed the revisions, she will send them to the Partners to sign.

NRCS Report: NRCS Report: Blake Glover, NRCS State Conservation reported that everyone has been busy with the ongoing projects. Blake shared that there is over \$20 million dollars' worth of funds to be obligated for EQIP, CSP, other NRCS programs.

Blake reported that he attended the CDEA meeting held in Suffolk County and stated it was a great meeting and he enjoyed the tour provided.

Blake reported that they have seventeen (17) positions to fill and will have four (4) summer interns.

State Committee Report: Bethany Bzduch, SWCC Ex. Dir. provided updates on the 2022 AEM report was completed much earlier than last year and has been completed.

Bethany reported that there are several upcoming meetings on June 8th is the Technical Advisory meeting at 10:00 a.m., June 20th is the next State Committee meeting to be held in Albany, and there are several Regional Area Conservation Manger's meetings from June 12th-June 21st with one meeting held in each state conservation region with lunch provided.

The State Committee sent out a survey to be completed by soil and water districts to be used for the 2024-29 five-year state committee strategic plan.

Bethany reported that she had the opportunity to be an NYS Envirothon evening oral presentation judge at the NYS Envirothon and it was her first time ever attending the NYS Envirothon. Bethany expressed her thanks to all those involved and how much she enjoyed being there.

Sam expressed how wonderful the NYS Envirothon was and how the committee kept him busy doing all sorts of things for both days. Sam stated it was another wonderful event and the committee did a great job.
