NYSCDEA' Report: Caitlin Stewart provided the following CDEA report:

- The CDEA meeting was held on May 30 31, at the Wyoming County Ag and Business Center, 36 Center St, Warsaw, NY 14569.
- New York State will host the 2024 National Conservation Foundation (NCF)-Envirothon July 28 August 3, 2024, at Hobart and William Smith Colleges, Geneva. Caitlin and her staff have volunteered and will be attending this event. Please consider volunteering and / or donating.
- The New York State Fair Committee selected the theme Conservation Districts: Then and Now for the 2024 and 2025 events and is recruiting volunteers to work booth shifts. - The National Association of Conservation Districts Northeast Region Meeting will be held August 9 14 in Boston, MA.
- The National Association of Conservation Districts 79th annual meeting will be held February 8

 12, 2025, in Salt Lake City, Utah.
- The Conservation Skills Workshop Committee met to discuss course topics, instructors, and the venue. Save the date: September 23 26, 2024.
- The CDEA Administrative Conference will be held November 18 & 19, 2024 in Saratoga Sprins, NY. This is being directed by Dustin Lewis, District Manager Saratoga SWCD.
- 2025 Water Quality Symposium (WQS) is in the works. Jessica Anderson has sent out RFP's and the CDEA Board will review and determine the 2025 location at their next meeting.

NRCS Report: Blake Glover, NRCS State Conservation reported on the Farm Bill, EQIP, RA Funds, and that last year at this time they had 125 employees, and they now have 160 employees.

State Committee Report: Bethany Bzduch, SWCC Executive Director reported on the hiring of Chastity Miller as the AEM Program Manager. Chastity comes from Franklin County SWCD as their District Manager starting in July.

Bethany reported they are wrapping up the 2023 AEM Annual reports. The summertime draft is out, and they will host their next SWCC meeting on July 16th in person in Albany. They will also have it virtually for those that are unable to attend in person.

Bethany reported she will be attending the NACD summer meeting to be in Boston August 9-11, 2024.
