RCS finalizing reopening plan for new school year

RAVENA-COEYMANS-SELKIRK — With the school year slated to begin Sept. 8, the Ravena-Coeymans-Selkirk school district is working on finalizing its reopening plan for the 2021-22 school year.

Students and staff will be returning to in-person instruction after a year of a hybrid format designed to prevent the transmission of the COVID-19 virus. The pandemic began in March 2020 in the United States and had significant impacts on education and how it is delivered to students.

This year marks the third academic year that has been affected by the pan-

demic. In March 2020, schools were shut down nationwide and classes immediately shifted to an online format for the remainder of the 2019-20 school

year. For the 2020-21 year, most schools moved to a hybrid instructional format, rotating students between virtual and in-person learning.

For the upcoming school year, RCS students will be returning to the classroom full-time with safety protocols in place.

“We have been strategizing how we will provide quality instruction while keeping our students and staff safe,” RCS District Superintendent Brian Bailey said in a letter to families Aug. 23.

Gov. Kathy Hochul on Aug. 24 mandated that students and staff statewide

Friendship Festival draws crowd despite rain

RAVENA — Despite rain — at times heavy — the Ravena Friendship Festival drew a crowd to Mosher Park on Saturday.

The festival returned to the village after a two-year hiatus, in 2019 due to a lack of volunteers and other reasons, and in 2020 because of the COVID-19 pandemic that put a stop to most large community events last summer.

But this year the festival was back, even with the rain.

“People continued to come — it didn’t really stop them, mostly the younger crowd,” Village Trustee Nancy Warner said late Saturday afternoon. “So now that the rain has stopped, I’m thinking the older crowd will come out.”

Hundreds of people did, eating festival food at the vendor booths that lined the street, playing in the bounce houses, taking

part in kids’ activities and games, and taking their turn at dunking whoever was in the dunking booth at the moment — village officials and residents took turns sitting in the hot seat, so to speak.

Driver killed in Route 9W crash

NEW BALTIMORE — A motorcycle driver died Aug. 24 following an accident with a pickup truck, said Steven Nevel, public information officer for state police Troop F.

Tyler Lane, 33, of New Baltimore, was pronounced dead at the scene by Greene County Coroner Paul Seney, Nevel said.

At about 8:47 p.m., a 2006 Harley Davidson motorcycle was traveling north on Route 9W, Nevel said. After the bike passed the intersection with Route 144, Lane lost control of his motorcycle and crossed over into the southbound lane, colliding with a 2017 Chevrolet Silverado pickup, Nevel said.

Police did not identify the driver of the pickup truck.

The unidentified driver was taken to Albany Medical Center with minor injuries, Nevel said.

Greene County 911 sent New Baltimore Fire Company, Greene County Paramedics and Ravena Rescue Squad

to the accident after receiving reports that the motorcycle struck the pickup truck head-on.

Town of Greenville Ambulance was requested to the scene under mutual aid.

Route 9W was closed between Route 144 and New Baltimore Road while fire and rescue crews worked.

The road was closed for several more hours while the state police Collision

Reconstruction Unit investigated the crash.

Both vehicles had to be towed from the scene.

The investigation by state police is continuing, Nevel said.

The accident was the fourth traffic fatality in Greene County this year. The most recent was July 6, when a Jeep Liberty struck a utility pole on Route 385 in Coxsackie. A Coxsackie man died in that crash. On June 19, a man from Kingston was killed when his motorcycle collided with a car on Route 32 in Kiskatom and a Westerlo woman died Jan. 14, after her car struck a rock wall on Route 23 in Cairo.

Two Greene County men were killed in auto accidents this year in Albany County. On July 25, a West Coxsackie man was killed in a two-car accident on the New York State Thruway in Coeymans. And on June 2, a Hannacroix man was killed in a head-on crash on River Road at Route 144 in the town of Bethlehem.

All children's activities were free thanks to contributions from the local community, festival organizer Caitlin Appleby said Saturday.

"Kid's activities are free due to the donations that were made by local businesses and the village," Appleby said. "The parents don't have to come out and spend money they don't have. It's not about making money, it's about bringing the community together to have a good day."

Appleby said the rain did not deter people from enjoying the day.

"People were still coming out," she said. "The kids — they had a blast. They did not care. They were wet, they were muddy and they were having so much fun, and that's what it is all about. If they were having a good time, that's all that matters."

Saturday was the 38th year of the festival, though it has not taken

place every consecutive year.

"We have only missed a couple of years for reasons beyond our control," Warner said. "I think seeing everybody here means a lot — the kids have had a ball. They are dirty from head to toe with the mud and the rain, and everybody seems very happy. That is what we want — we want people to come out, visitors to come in and for everybody to have a great time."

Local businesses sold their wares and mingled with the community. For Eck's Farms, it was the first time participating in the fair, Christina Burns from Eck's Farms said. She was selling cookies, whoopie pies produced by an Amish baker, maple syrup, jams and produce.

"This is the first year we have done this," Burns said. "We wanted to get a little more involved in the community, so we figured this year we would give it a try."

For some, the festival is an emotional tie to the

community they recall from their earliest years.

"This was a big staple of my childhood," Appleby said. "I grew up on Western Avenue — this was the first time my mom let me walk around by myself. I remember the first time I got to spend my own money was at this festival. I have a lot of really positive memories of this festival, so I wanted to give that to future generations. It is important to have those types of memories to keep people in the community."

Organizing the event each year is a labor of love for Appleby, and one that means a great deal to her.

"This is very special for me," she said, wiping away a tear. "It is a lot of work, but my favorite part is when I am sitting here at the fireworks at night and watching everybody together, having a good time, and the fireworks are going off — it's just beautiful and makes it all worth it."

will be required to wear face masks indoors while on school grounds and buses, regardless of vaccination status due to the high transmission rates of the Delta variant of the virus. Face coverings outdoors are optional at this time, according to the governor's office.

Individuals ages 12 and up are eligible to be inoculated against the virus. Hochul said last week she plans to require teachers and staff to be vaccinated or face regular testing for the virus.

"We are working to require vaccinations for all school personnel with an option to test out weekly," Hochul said Aug. 24.

The state does not have plans to require eligible students to be inoculated

at this time, but strongly encourages them to do so as the best layer of protection from serious illness or death from the COVID-19 virus.

Social distancing will continue to be practiced in the RCS district as the new school year begins, but recommendations by the U.S. Centers for Disease Control and Prevention have been reduced from 6 feet to 3 feet.

"The updated guidance from the Centers for Disease Control has identified that social distancing at 3 feet will be acceptable in most situations," Bailey said in the letter. "This will be helpful as we set up our classrooms. Day-to-day logistics such as arrival, dismissal, lunches, travel between classes, and the use/sharing of materials are being examined so that

our schools may operate smoothly while maintaining a sense of community and normalcy.

"We are very excited for the return of our students on September 8."

RCS students will also return to their traditional buildings. Grade groupings were modified last year to accommodate social distancing requirements, but all students will be back in the usual buildings for their grade.

Bus transportation will return to full capacity for the 2021-22 school year and masks must be worn at all times by everyone on the bus, according to an Aug. 27 letter from the district. Windows will be opened, weather permitting, to increase air circulation and to discourage the potential spread of the coronavirus.

Our highway superintendent and his crew are hard at work replacing culvert pipes, maintaining the grass alongside of the roads, and paving nearly three miles of town road in Coeymans Hollow.

The Town Parks Department is working every day to maintain our parks and cemeteries, which is no small task this year, especially given the large amount of rain that has fallen. The construction plans for a permanent bathroom facility at the Coeymans Landing Park are finished and plans are underway to draft similar plans for Joralemon Park. Our engineers are hard at work, preparing plans for the \$1,212,000 Coeymans Landing Park Improvement Project, which is anticipated to begin in the spring of 2022. - Troop 1 of Coeymans had an enjoyable 10-day camping trip at Canada Lake in the Adirondack

Mountains. The party

consisted of 18 boys besides the scoutmaster, Prof. B.J. Youker. Most of the time was spent in hiking in the surrounding country. On these hikes the boys visited over 20 lakes. The most interesting of these trips was a 30-mile hike to Tommany Mountain, where a visit was made with a fire warden.

- Supt. Seabridge is repairing the village streets.

- Mr. S. Vincent has plans completed, and the work of constructing a large public hall, in addition to his boarding house at the Junction, has been commenced.

- Solomon Whitbeck, Theodore Whitbeck, Miss Jennie Whitbeck and William S. Briggs Jr. left on Monday to attend school at Starkey Seminary, Yates County.

- Indian Fields band will give a grand river excursion from this place to Saugerties, Sept. 9. In addition to the cornet band, a full orchestra will be in attendance. Refreshments furnished on board. The super barge Harvest Queen and powerful steamer Hope have been secured for the occasion.

- A large eagle was seen flying over this village Sunday afternoon.

Priest accused of sex abuse worked in Cossackie

COXSACKIE — A priest accused of sexual abuse under the Child Victims Act formerly was assigned to a Cossackie church, the Roman Catholic Diocese of Albany said.

The diocese released a statement Aug. 21 announcing that the Rev. Gregory Weider, 84, is on administrative leave following an allegation of sexual abuse. Weider had retired from full-time ministry in 2010, but had been working as Sacramental Minister at Sacred Heart in Margaretville and its mission, St. Anne's in Andes.

Weider had worked at St. Mary's in Cossackie from October 1977 to March 1982, the diocese said. He was ordained in 1963.

A representative from St. Mary's Church declined to comment on the matter.

Weider also served at Blessed Sacrament, Mohawk; St. Anthony, Schenectady; St. Agnes, Cohoes; St. Thomas the Apostle, Delmar; Holy Cross, Albany; Sacred aHoly Trinity, Schaghticoke, which was the merger of St. John the Baptist and Our Lady of Mount Carmel, Johnsonville, and St. Monica, Valley Falls.

He also served as diocesan chaplain for scouting; assistant national

chaplain for scouting; chaplain at Samaritan Hospital in Troy, with residence at Our Lady of Victory, and chaplain at St. Mary's Hospital, Amsterdam.

Weider's leave became effective Aug. 14 and was handed down by Bishop Edward B. Scharfenberger. During his leave, Weider "will not publicly officiate at sacraments, wear clerical garb or present himself as a priest," according to the statement.

"The Albany Diocese urges anyone who as a child was sexually abused by a Catholic priest or deacon to report the matter to a law enforcement agency or to the Diocese," the statement reads.

The announcement comes about a month after a New York City law firm introduced an updated public database with 13 new alleged perpetrators accused of child sexual abuse in the Roman Catholic Diocese of Albany filed under the

Child Victims Act this year.

Signed into law Jan. 28, 2019, the Child Victims Act gave survivors of child sexual abuse a vehicle to file civil lawsuits against their abusers for incidents that happened before age 18. Cases had to be filed before the lookback window closed Aug. 13.

"We are still reviewing these cases, though we cannot comment on anything in litigation," Albany Diocese Director of Communications Mary DeTurris Poust said in a statement July 23. "Bishop Scharfenberger and the Roman Catholic Diocese of Albany take all allegations of abuse seriously and remain committed to uncovering the truth without fear or favor. Our first concern is for survivors, and we stand ready to accompany them, support them, and assist them."

Thousands of clergymen who served in parishes across the state have been named in more than 3,300 lawsuits involving the Catholic Church, its affiliated organizations and employees since Aug. 14, 2019. The complaints allege abuse by more than 1,700 individuals, including cardinals, bishops, priests, members of religious orders and lay staff.

More than 8% of complaints involved the Albany Diocese.

I imagine while I was making this observation that somewhere in this big world of ours, far, far away, some old guy is staring at a head of cabbage or a bunch of broccoli and trying to figure out how to or why someone would eat it.

I got to reminiscing about food in my youth. If it was meat, I knew it well. Usually I could tell you its name and family history. We raised a lot of our own food and got used to having this year's pets be next year's dinners.

I guess I hadn't appreciated how well we ate and how healthy our diet was. I was raised on free-range chickens and organic eggs. The chickens ate only organic foods. We didn't real-

ize they were free-range, we just thought we were letting them run around loose.

The cracked corn we fed them had no growth hormones or pesticides. I'm sure the bugs and crawly things they ate were organic, probably low fat and sodium-free, too. Our beef came from grass-fed cows, because grass was what cows ate in the summer and they ate dried grass called hay in the winter. Pork came from pigs fed an organic-based food called "slop" made from the finest kitchen scraps, grain and water or raw milk all cooked together.

Most of our milk was fresh from the cow, not pasteurized and certainly not homogenized. It had a thick layer of cream floating on the top that had to be stirred or shak-

en into the rest. Skim the cream off and you had skim milk — that no fat, blue milk you can still find in the market.

The vegetables from our garden were all organic, they had holes in them and bugs crawling over them just like the finest organic foods to be found in the market today. The only fertilizer used to grow them was manure from the barn, which was all natural and had come directly from the animal's organs so it had to be organic.

All the foods I ate growing up are still there in the market. They're labeled "organic" and "all natural" and cost more than their unnatural and inorganic counterparts, but it's nice to see them still around. It brings back pleasant memories of my "free-range" childhood.

Safely getting rid of pesky critters

When I started working for Cornell Cooperative Extension back in the mid-1970s, I was told that under no circumstances should I pass on home remedies to clients looking for information.

The reason, of course, was due to liability concerns. If I suggested a home remedy that either did not work or resulted in damage, the university could be held liable for my bad advice.

All the information I was allowed to share was based on scientific research conducted by universities, government agencies or, more often, by chemical companies trying to sell their products.

When it came to making pesticide recommendations, I was told, "The label is the law." If a specific pest was not listed on the label of the product, it was a crime to use it on that particular pest.

I almost lost my job early on when I jokingly suggested in one of my "Home and Garden" newsletters, that a live chicken could be used to clean soot and creosote from a chimney. I told readers to tie a rope around the chicken's legs and pull it up and down the chimney. The bird's flapping wings would effectively dislodge soot. A local poultry farmer did not see the humor in my comment and neither did the local PETA people.

Now that I am happily retired and not getting paid for my advice, I can suggest home remedies that may or may not work and let readers try them out for themselves, if they so desire. This week I will pass on some home remedies that readers have suggested, or that I have used myself.

Perhaps the most common pest control questions I receive in recent years are concerning "critters." Deer have become a major nuisance throughout the region, particularly in suburban areas.

One reader suggested a remedy that others

have tried and found to be quite effective. Beat two raw eggs, mix with a cup of milk and allow the mixture to turn rancid in an outdoor bucket or pail. Add a gallon of water and a few drops of dishwashing liquid. Mix well, strain out the solids and spray on your landscape plants. This mixture works quite well for weeks until it eventually gets washed or weathers off. Some people will add some crushed garlic to the mix, which may offer additional protection against other critters.

Chipmunks also are common pests and they are indeed hard to deter. One reader was having problems with them climbing into her hanging baskets of petunias, where they chewed through the flower stalks. She tried putting garlic in the baskets, but the chipmunks were unfazed. Next, she tried putting sprigs of lavender in the basket and that seems to have done the trick. I would love to hear from other readers about this technique. I much prefer the fragrance of lavender to garlic.

Most people know that deer ticks may spread Lyme disease and other serious illness, but fewer people know that the ticks must acquire the pathogens from small rodents, like mice. It is these small, mammal rodents that maintain and pass on the disease-causing agents to their offspring. Newly hatched ticks acquire the pathogens in their first blood meal

and carry them into their nymph and adult stages, when they are more likely to feed on humans.

The repellent "permethrin" is very effective at both repelling and killing ticks. If you save cardboard tubes, such as from toilet paper or paper towels, and stuff them with cotton balls that have been sprayed with permethrin (wear gloves), mice will often use these cotton balls as nesting material, thus killing ticks. One reader reports that this practice has essentially eliminated deer ticks on his immediate property. He leaves the tubes anywhere that mice might nest such as in his attic, sheds, basement and other outbuildings.

Those of you who grow phlox or zinnias, or hollyhocks, know that powdery mildew, a fungal disease, can devastate these as well as many other ornamental and even food crops. Mixing two tablespoons of baking soda with a teaspoon of salad oil, plus a few drops of dishwashing detergent and adding a gallon of water, make a very effective protectant fungicide that can be sprayed on susceptible plants before infection occurs.

Nobody likes having a skunk nesting under a shed, porch or outbuilding. Since skunks are generally nocturnal, the solution often involves sealing the entrance when the skunks are outside. To ensure that you do not accidentally seal them inside, spread some flour on the ground where you think the animal is getting in and out. Go out at night looking for their tell-tale tracks, leading away from the structure and seal the entrance point.

Finally, to find out where bats may be getting in and out of your attic, put several bright lights in the attic at night and look for where the light is escaping. Seal the openings at night when the bats are outside.

"That place is a den of iniquity," he said.

Maybe he's right! I'm strung out on coffee all day long!

I remember being surprised to learn that gambling is an addiction. I didn't understand why. I thought substances like alcohol, nicotine, drugs or caffeine cause addictions. It turns out that chronic gamblers are addicted to the rush they feel when they roll the dice. What causes that rush? The simple answer is their brain.

They've programmed themselves to become addicted to a neurochemical cocktail that causes them to feel the gambler's rush.

What is a feeling? A feeling is produced by a neurochemical or a blend of neurochemicals called peptides.

What causes the peptides to be produced by the brain? Generally speaking, it's the thoughts you think. Every thought produces a peptide or a blend of peptides that cause you to have feelings.

Feelings are the byproduct of a chemical reaction that starts with a single thought.

In the book "Evolve Your Brain" author Joe Dispenza says, "Conscious thoughts, repeated often enough, become unconscious thinking."

Most people meditate

on the same thought patterns for so long they program their brain to produce a blend of peptides unconsciously without even thinking about it. These peptides cause them to feel a certain way.

Even when a pattern of thinking causes a person pain, it's difficult for them to change; oftentimes it's because they are addicted to their emotions. This is a major reason most people find changing their thought patterns impossibly difficult.

I spent many years taking acting classes. The method of acting I studied taught me that I should never act, instead I should authentically feel what my character is supposed to feel. Rather than pretend to cry, I was taught to find a way to truly cry. It's not easy for me

to cry during a performance, but I've done it a few times on stage, and for the camera. The way I do it is by thinking thoughts that make me cry — sad thoughts, depressing thoughts.

Good actors are living proof that changing your thoughts will change your feelings.

A good question to ask yourself is, "Where have my thoughts led me?" Thoughts are like the steering wheel of a car, they are steering your destiny. Have your thoughts led you to feel emotions that keep you from the life you really want?

We've been taught from an early age that drug and alcohol addictions will ruin your life. Is it possible to be addicted to negative emotions?

It is possible to change, at any age.

Sometimes it helps to think about what you have rather than what you don't have. The glass half full approach!

Instead of allowing your thoughts to make you feel bad, you can use your thoughts to make you feel good.

Joe Dispenza says, "The process of change requires unlearning. It requires breaking the habit of the old self and reinventing a new self."

When you change the way you think, you become a new person. Jesus called this process "Repentance."

If you want to change the way you feel, an excellent place to start is by changing the thoughts that you think.

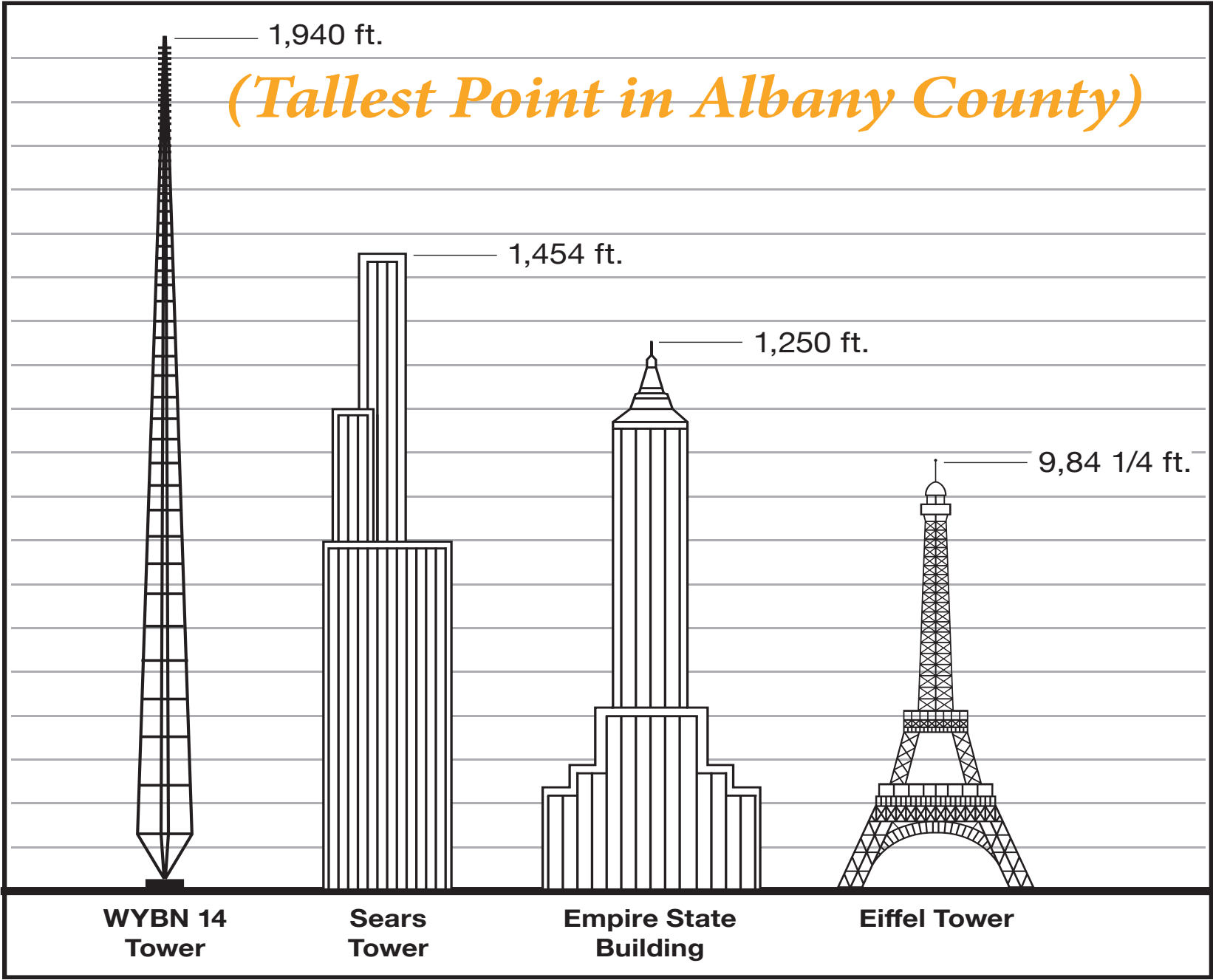

Dave MacLauchlin



One year ago this month, **Dave MacLauchlin**, started as manager of the **Lafarge** cement plant in Ravena – an opportunity that enabled him both to utilize his two decades of industry expertise and realize a dream of returning to his home state of New York.

But the job also presented significant challenges to MacLauchlin, 45, a Western Mohawk Valley native and Clarkson University graduate. He arrived five months after the coronavirus pandemic forced the closure of everything but essential businesses across the state.

The Lafarge Ravena plant, MacLauchlin said, shuttered briefly in April, but otherwise “operated successfully” throughout the Covid-19 crisis and never experienced an outbreak.

“That’s a testament to the workforce,” he said.

Now that the Covid restrictions have eased, MacLauchlin is focused on getting into the community and forging relationships. He is working to highlight how the local team has “evolved as an organization” and the plant has “evolved as a site.”

“Our goal is to be a good member of the community, to be a respected member of the community,” he explained. The plant is the largest employer in Southern Albany County, with 150 workers, and the largest contributor of local property taxes.

MacLauchlin often points to Ravena plant’s multimillion-dollar modernization project completed in 2017. He notes it has produced cement for many projects, including the GlobalFoundries site in Malta, which announced a significant expansion; and looks forward to playing a key role in helping New York reach its ambitious renewable energy goals.

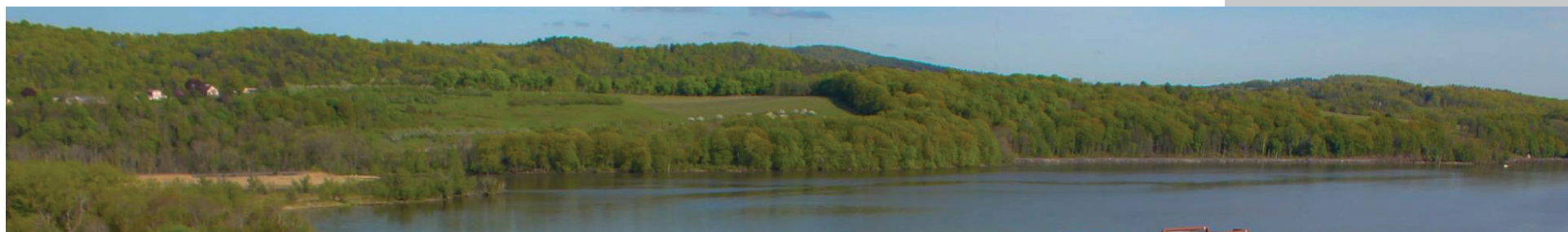





A NIGHT FOR CHAMPIONS

CHASIN' RACIN'

Standing on the infield of the famed half-mile that sits between the backdrop of the Mohawk River off the back stretch and the old covered grandstand on the front stretch where I have sat for so many Saturday nights at the "Track of Champions" Fonda Speedway, I could see the grandstands starting to fill early and fill fast.

It was Championship Night, along with Fan Appreciation night. It was also the night we paid tribute to the "Gentleman," Harry Peek, a nickname that fit him well.

FONDA SPEEDWAY

With 23 Late Model wins and the 1969 championship along with 21 Modified wins in the '70s, with his first win being the Fonda 200, Peek is a deserving member of the Hall of Fame. Way ahead of his time in what he built, immaculately prepared cars along with his clean driving style and fan friendly attitude made him a fan favorite as well as highly respected in the pits. Championship night is the whole year coming down to this one very special night. It is what every driver and team work so many hard hours in the shop for. They sacrifice so much time with family and their personal life. They do this for the prestigious Fonda Speedway championship and to put on a show for the fans.

But, if you think about it, there is only one champion, well in most cases, and there are 20-plus teams in the pits per division. Do they all think they are going to win the championship? No, but it is in their blood, that's what makes dirt racing teams and fans come back week after week. No follow the leader, good hard dirt throwing, 2- and 3-wide nerf bar to nerf bar racing action from green to checker and that is what the SUNOCO Modified title came down to.

FAN APPRECIATION NIGHT

Fans look forward to Fan Appreciation Night each year. What a great time was had by both the drivers as well as the fans with the meet and greet down on the front stretch. Drivers handed out plenty of candy along with pictures and autographs to the fans. It is great for the fans to see the man behind the helmet and get to meet their hero up close, something that does not happen as it did when I was young.

Just the look on the kids' faces, young and old, as they get up close to the cars and in some cases get to climb in.

To think back, no one was even sure what was going to happen during the 2021 racing season.

Would there even be a racing season? If there was a season, would it be with or without fans in the stands, those who keep short-track racing alive as they make their way through the gates across America? The 2020 season was tough on the entire racing community, from fans to those who make a living in the racing industry, and it did not start out any easier in 2021.

Still unsure of what the new season would bring, fans no fans, racing or no racing, but still teams and promoters had to go forward and get ready for an uncertain season.

As a race fan I lost my hero on April 1 with the passing of Mr. "Jumpin" Jack Johnson. He was so much more than the driver of the orange 12A, he was our hero. Fonda gained some cars, one of them being Ronnie Johnson, as I call it, came back home, along with Mike Mahaney, who is a threat no matter where he races that just added to the talent filled Modified field. Well, the season did start and here I was on a beautiful Saturday night, the old covered grandstand filled with race fans and it was the next to last race of the season with only the Fonda 200 weekend left on the schedule Sept. 16-18.

The infield was packed with the race cars from the glory days of racing with the Mohawk Valley Vintage Dirt Modified Series on pit road and more fans parked up on what used to be known as Street Stock hill. Kids out playing and having fun, fans tailgating, and a full field of cars in the pits off turns 3 and 4 ready to take on the "Track of Champions."

The Old Girl that only a few weeks back was again under water was looking ready for the night's action and after the heats it proved she was going to play nice and the championship was on the shoulders of the teams and their driver.

MODIFIEDS

The Modifieds came to the line with Rocky Warner starting eighth, leading Ronnie Johnson starting 10th by just four points. It was anyone's championship in the top 4 that also included Josh Hohenforst starting seventh, who has been in the thick of the battle all year, including leading the points during the early part of the season, and Stewart Friesen, who went into the night with nine wins on the season only 14 points back would start in 11th.

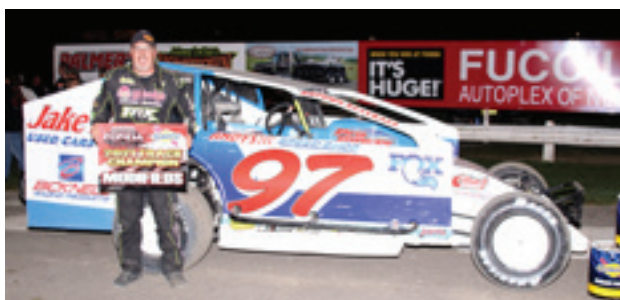
At the drop of the green it was JaMike Sowle getting the early advantage and quickly started to put distance on the field as Bobby Varin and Craig

Hanson quickly moved into the top 3 as outside pole sitter Ancel Collins slowed and went pit side. Coming out of nowhere and coming fast was 11th place starter Stewart Friesen picking off cars and working his way into the top 5.

With Sowle out to a commanding lead that would soon change as the caution was out, which brought the field to Sowle's rear deck. Once back to green with Sowle to the high side went right back to the lead with Friesen now second using the bottom of turns 1 and 2 to take the new lead as he ran down the back stretch and had a sizable lead over Hanson and Sowle, who was holding his own with the point contenders of Warner and Johnson in fourth and fifth, with eyes on the championship.

The caution would be out for Bobby Varin after contact with the front stretch wall and a right rear flat going to the hot pit and returned without losing the lap. Back to green it was all Friesen doing what he needed to do to win the championship and leaving the rest of the contenders to fight it out and that they did.

With Hanson in second, Johnson worked his way around Warner and now had Hanson to get by as he did on lap 23, with

Friesen in his own ZIP code out front. Now it was Warner who had to get by Hanson as they raced hard behind the leaders with Warner now not just racing for third but for a tie in the championship.

After a great race with Hanson, Warner worked his way to the bottom of 1 and 2 and into third with just two laps to go. For the 10th time in the 2021 season, Stewart Friesen picked up the win with a dominating performance as Johnson, Warner, Hanson and Jessica, who put on a late charge, rounded out the top 5 in a great SUNOCO Modified feature. Congratulations to the co-champions, Ronnie Johnson and Rocky Warner, who both had to race their way to the championship.

For Johnson it was his third championship, with his first two coming in 2011 and 2016, and for Warner this will be his second Modified title with his first in 2019.

Along with the two Modified titles, Warner had four straight 602 Sportsman titles, 2011 Pro Stock champion and the 2005 and 2007 co-champion in the Street Stocks. You can't write a script any better for a movie than this year's point chase that changed hands weekly, found RJ coming home again, and then

there was Jack Lehner, who was the points leader in the Nelson 85 when they lost their power plant forcing the team to call an early end to their season. There is one thing for sure the SUNOCO Modified field is alive and well and loaded with talent and it shows when the point chase comes down to the last race of the season.

SPORTSMAN

Going into Championship Night for the Swager Factory Apparel Crate 602 Sportsman Chad Edwards had a 35-point lead going in over Cody Clark, who had a mathematical chance of pulling off the championship if Edwards, the two-time champion in 2018 and 2020, had a bad night.

At the drop of the green it was Michael McCallion with the early lead, a lead that was short lived after making contact with the inside retaining wall and spun as Tony Farone became the new leader with Payton Talbot holding down second on the restart.

Coming out of turn 4, Farone and Talbot were in a drag race with Talbot the new leader. On the move from the fifth row starting spot was 2019 Sportsman champion Tim Hartman Jr., who came into the night third in points and was into the top 3 and started to work on Farone working his way to second.

Behind the leaders there was a dog fight going on as Cody Clark was working his way to the front as was Tanner Warner, as Edwards was finding it tough to work a way through the always tough 602 class. The caution flew, closing up the field.

Once back to green Talbot again had to hold off Hartman as the young Talbot continued to control the pace when the caution flew for a grinding hit on the front stretch as Addison Bowman stopped and Kurtis Hohensheldt made heavy contact with the stopped racer, causing heavy damage to both cars. Both drivers were able to walk away.

As quick as the green was out the yellow quickly followed as Mark Mortensen had a flat and headed to the hot pit after contact with another car and returned. Once back to green it was all Talbot, looking like a veteran, the young gun hit his marks, working through traffic and went on to record his first win at the Fonda Speedway over Hartman Jr., Clark, Brian Calabrese and Tanner Warner rounding out the top 5 in the very competitive feature that found Chad Edwards finishing seventh and holding on to win his third championship for long-time Fonda Speedway driver, car owner and Hall of Fame member John Kollar.

PRO STOCK

Going into the Pro Stock

feature, three-time Fonda Track champion Nick Stone had a commanding 74-point lead over Kenny Gates, the all-time feature winner and seven-time track champion.

It was Ivan Joslin taking early command with Jason Morrison not far behind, but it did not take long before things to heat up. In a great battle, Joslin and Morrison ran side by side as the two put on a great show out front.

Behind the leaders the heavy hitters Luke Horning, Nick Stone and Kenny Gates were working their way to the front. Some great side-by-side action kept the competition tight as Stone was fast as was Horning as they were coming as they moved into the top 5 before half way. No pressure on Morrison, but he had Stone, Joslin, Horning and Gates now in the top 5 and still racing for the win and the championship, and Beau Ballard, who started in the ninth row and was now just outside the top 5.

Just past halfway the yellow was out after Ivan Joslin was caught up with Cliff Haslun, who blew a tire and made contact with the wall, leaving Joslin with nowhere to go.

Back to green and it was Stone the leader with Horning powering his way to second. With Stone out front he held on for the win, his sixth of the year. Following Stone to the line was Horning, Morrison holding on for a great run, Ballard working his way to a solid top 5 and Kenny Gates rounding out the top 5.

MORE RACING

In other racing action, Stephen Gray picked up the Montgomery County Office for the Aging Limited Sportsman win over Jeremy Slosek, Kyle Dingman, Clayton DuMond and Carter Gibbons rounded out the top 5 and is the 2021 Limited Sportsman champion. The 4-cyl once again found Kerrie Hollenback and Slappy White picking up wins and the Championship in their respected classes. For Hollenback it was his eighth championship and for White it was his first track championship.

The Mohawk Valley Vintage Dirt Modified Series had a strong contingent of cars sitting on the infield. With Randy Delaney (Modified), Curtis Condon (Late Model), Bryon Seyfried (Sportsman), George Palmer (Mystic) and Bryon Scofield (Antique) winners in their features. It is always great to see the past come alive on the track and show the new fans where this sport came from with a rolling history.

Well, folks, the great Fonda 200 will be here before we know it. Hard to believe the race season went by so quickly. See you all there!

Knowing when to stand and when to be silent

Each week I spend a portion of my days writing and preparing messages. I pray and seek the Lord's voice as I strain my spiritual ear to hear the direction he is leading me.

AG issues warning about scam targeting employees

NEW YORK – New York Attorney General Letitia James issued an alert to New Yorkers warning them about the "Boss Scam," a common text and email scam in which fraudsters pose as a consumer's employer and

request gift cards due to a purported work emergency. This scam may be on the rise during the COVID-19 pandemic since many

employees are working remotely.

"Due to COVID-19 safety measures, many employees are still working remotely, which makes it easier to fall for this common scam," James said. "A legitimate employer will never ask you to purchase gift cards in order to pay clients or for other business purchases. I urge all New Yorkers to be on the alert for this type of fraud, and to protect themselves and their wallets by following our simple tips."

The scam typically works as follows: An employee receives a text or an email from someone pretending to be their employer who claims there is an urgent matter. The text or email may "spoof" an employer's actual name, phone number or email address, making it seem legitimate. The "employer" then requests that the employee buy a certain number of Target or other store gift cards in specific denominations and promises to reimburse the employee quickly. As in the real example below, the "employer" may ask the employee to scratch off the back of the card to reveal the PIN or claim code and send photos of the card to the scammer.

New Yorkers who have been targeted by this scam are urged to file a complaint by completing and submitting a Consumer Frauds and Protection Bureau online complaint form or by calling 800-771-7755.

While investing can be an intimidating topic for those just getting started, it doesn't need to be. If you're new to investing, know that it all starts with financial literacy – understanding the basics.

Here's a primer:

- Study common investment terminology. The stock market is rife with complex concepts, so start by getting a grasp of the frequently used terms and concepts. It helps to understand the language of investing, from asset allocation to ETF and beyond. To break it all down, use an online investment dictionary that provides plain-English definitions of common investment terms, or ask your financial advisor to explain them to you.

- Enroll in a class. Take advantage of free webinars, seminars or workshops on investing fundamentals. If you prefer learning in a classroom setting, look for basic courses on investing, how the stock market works or personal finance at a local college or university.

- Follow the news. Start following the business and financial sections of your favorite media outlet to get a healthy dose of investment know-how. You'll begin to understand the types of business activities that influence the marketplace—for example, oil prices or new housing starts—and gain an appreciation for what's considered newsworthy. As you become more attuned to global markets, you'll start to see the ripple effect of mergers and acquisitions,

product innovations and even front-page news stories—from natural disasters to general elections and terrorist events—on Wall Street confidence.

- Watch investment programs. Public radio and television stations often feature investment programs aimed at new and seasoned investors. Even your local news channels may include a market segment. Be wary of infomercials disguised as informational investment programs, though.

- Check out stock market apps. There are hundreds of apps available today focused on helping consumers understand investing. Before downloading an app, check the reviews and opt for those that have been vetted by trusted sources.

- Track your favorite companies. To better understand the movement of individual stocks, pick several of your favorite publicly traded companies to follow. Then, check their stock price, company newsroom and social media accounts each day. Tracking the stocks over time will help you understand how company announcements and actions, such as a product launch or comment by an executive, may affect the stock price.

- Work with a financial professional. A professional can help you understand your investment

options, and help you make financial decisions that are best for your individual needs. Work with someone who is willing to explain investment concepts and provide educational materials. Tell your professional about your desire to learn more about the market. He or she will likely be willing to send you news articles, add you to a newsletter or give you a call to discuss market news that may interest you.

If I apply now, when will I get my first Social Security payment?

Dear Rusty:
If I were to apply for my Social Security retirement (I'm 68 on Aug. 1, 2021), when could I realistically expect to receive my first check?


Signed: Ready to Claim

Dear Ready:
Social Security suggests applying for benefits two to three months before you wish them to begin, to allow time for processing your application. When you apply, you will specify the month you wish your benefits to start, and that is when your benefits will officially begin. But Social Security pays

benefits in the month following the month they are earned. So if, for example, you applied and specified September as your benefit start month, your benefit for that month wouldn't be received until October. The payment date for you will be on the second Wednesday (because you were born between the first and 10th of the month), and your payment won't be by check but rather by direct deposit into your bank account. Here are a few other things you should be aware of:

- Since you were born on the first of the month, your benefit is computed using the previous month as your eligibility date. If your year of birth was

1953, your full retirement age (FRA) was 66, which means that you actually reached your FRA in July 2019.

- Since you reached your FRA of 66, you have been

earning Delayed Retirement Credits (DRCs) at the rate of 0.67% per month (8% additional benefit per year). You can earn DRCs up to age 70, at which point your SS benefit would be 32% more than it would have been at your FRA.

- If you will be 68 on Aug. 1, you have already earned 16% additional benefit through DRCs. That means your benefit, if claimed to start in July, will be 16% more than it would have been at age 66. You will specify the month you wish your benefit to start when you apply.
- Social Security applies DRCs in January of each year, so if you apply mid-year 2021, your DRCs

earned in 2021 won't be applied to your benefit payment until January of 2022.

- You can claim up to 6 months retroactive benefits, which would be paid in a lump sum. If you choose to take retroactive benefits your "benefit-start-month" will be backdated by 6 months, your benefit amount will be reduced accordingly (by 4%), and you'll get that reduced benefit for the rest of your life (except for Cost of Living Adjustments annually awarded).

So, this may be more detail than you expected for your simple question, but claiming SS is a serious decision and it's important you have complete information before you apply.

Smoking and cannabis: What you need to know

After years of eager anticipation by some and mounting trepidation from others, New York state legalized the recreational use of marijuana

in March of this year. Adults 21 and older are now allowed to possess up to three ounces of cannabis and to use, smoke, ingest or otherwise consume cannabis products. They can also give (but not sell) them

to others who meet the same age requirement. A new state agency, the Office of Cannabis Management, is being created to oversee and implement the law and will eventually write rules to establish and regulate adult-use cannabis retail dispensaries and on-site consumption licenses and to clarify other aspects of the law. In the meantime, here are a few commonly asked questions:

Q: Can counties opt out?

A: Cities, towns and villages (but not counties) can opt-out of

allowing adult-use cannabis retail dispensaries or on-site consumption licenses from locating within their jurisdictions. Municipalities cannot opt out of adult-use legalization.

Q: Is smoking cannabis allowed anywhere?

A: No. New York's Clean Indoor Air Act now applies to smoking both tobacco and cannabis (and to vaping.) The long list of places the CIAA prohibits smoking includes: all indoor worksites and places of employment; bars and restaurants; mass transportation, such as sub-

ways, buses, vans, taxis and limousines; public transportation terminals; schools, colleges and universities; childcare facilities; indoor arenas; zoos; grounds of hospitals, residential healthcare facilities and public libraries. The Marijuana Regulation & Taxation Act (MRTA) also prohibits smoking cannabis in cars and other vehicles. As a general rule, where smoking tobacco is allowed, so is smoking cannabis; where smoking tobacco is prohibited, so is smoking cannabis.

Here’s why you should jump on the cauliflower bandwagon

Cauliflower is a cruciferous vegetable that has risen in popularity lately due to its versatility, incredible health benefits and anti-cancer fighting properties.

“It’s possible that future studies could show sulforaphane to be a safe supplement to give people at risk of developing schizophrenia as a way to prevent, delay the onset of symptoms,” said Akira Sawa, director of the Johns Hopkins Schizophrenia Center.

However, scientists say that while more research is needed, they’re encouraged by these findings.

When it comes to reducing inflammation, cruciferous vegetables top the charts! Chronic inflammation is the root cause of all disease including cancer, arthritis and heart disease.

Making cauliflower a regular part of your diet may also help promote cardiovascular health and reduce your risk of developing atherosclerosis. Research has also proven that antithrombotic and antiplatelet function of Indole-3-carbinol found in cauliflower contributes significantly towards a healthy heart.

And if you are looking to drop a few pesky pounds, then cruciferous vegetables like cauliflower should be your new best friend!

“Fiber promotes good bowel health, lowers the risk of cancer and heart disease and also controls your blood sugar,” explains Amy Kranick, R.D., at Vanderbilt University Medical Center in Nashville, Tennessee.

And these low-calorie, fiber-rich veggies promote satiety, kill cravings and lower levels of LDL (bad) cholesterol.

But what if you’re not a cauliflower fan? Well, other cruciferous vegetables like Brussels sprouts and broccoli also offer the same incredible health and cancer-fighting ben-

efits.

For most of us, cauliflower is a healthy option,

but there are a few exceptions. If you have a thyroid issue, cruciferous vegetables may interfere with the absorption of iodine, which is needed for the production of thyroid hormones.

If you are on blood-thinning medication such as warfarin, your doctor may suggest you monitor vitamin K foods like cauliflower.

ALBANY — The Albany Stratton VA Medical Center is enrolling veterans into the Million Veteran Program, a national research program that studies how differences in genes, lifestyle and military experiences affect veterans' health and illnesses.

The goal is to one day give veterans specialized care with targeted treatments and preventions based on their genetics and medical history.

Veterans can enroll online at www.mvp.va.gov or by scheduling an appointment at the Stratton VA by calling 866-441-6075. You do not need to receive VA health care to join VA's Million Veteran Program or schedule an appointment at the facility.

What is the Million Veteran Program (MVP)?

Since launching in 2011, nearly 840,000 veteran partners have joined MVP, helping

researchers better understand the genetics of disease in veterans. By collecting DNA from as many veterans as possible, along with information on their health, lifestyle and military experiences, researchers are beginning to answer important questions like:

- Why does a certain treatment work well for some veterans but not others?
- Why are some veterans at greater risk for developing an

illness?

- How can we prevent certain illnesses in the first place?

If more women and diverse populations enroll, MVP researchers can discover new medical breakthroughs that work for all veterans.

What does it mean to enroll?

To join MVP, you'll be asked to:

- Complete a consent process online at www.mvp.va.gov or at the Albany Stratton VA Medical

Center by calling 1-866-441-6075 to make an appointment.

- Allow access to your health records.
- Provide a one-time blood sample for genetic analysis.
- Fill out occasional surveys about your health and lifestyle.

Once enrolled, you may be contacted again on a periodic basis if additional information is requested, or if there is a research opportunity you may want to consider. You will also receive newsletters about the program at least once a year with updates on research findings and other topics of interest.
