## Skip Sweepstakes Official Terms

Effective Date: December 3, 2025

# NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.

- 1. Overview. These Terms (these "Terms") govern the Skip Sweepstakes (the "Sweepstakes") administered by YoGovernment Inc. d/b/a Skip (the "Company"). By entering the Sweepstakes, also known as "Skip Instant Grants", you agree to be bound by these Terms. Additional details, timing, and prize information for each Sweepstakes will be provided on the Company's website (the "Sweepstakes Details"). Any changes to these Terms will be posted on the Company's website, and your continued participation in the Sweepstakes constitutes acceptance of any such changes.
- 2. **Not a Skill-Based Contest.** The Sweepstakes is a game of chance and winners are selected randomly. It is not a skill-based contest or competition, and no judging or evaluation of entries will occur.

## 3. Eligibility.

- **3.1. Minimum Age.** The Sweepstakes is open only to individuals who are (i) 18 years of age or older at the time of entry and (ii) the age of majority in their state or territory of residence.
- **3.2. Residency.** The Sweepstakes is open only to legal residents of the United States and U.S. territories who meet all eligibility requirements.
- **3.3.** No Purchase Necessary. No purchase, payment, subscription, or upgrade is required to enter. Creating a free Skip account and submitting the required application is sufficient to enter.
- **3.4. How to Enter.** To enter, participants must: (i) create a free Skip account; and (ii) complete the Sweepstakes application, which includes a short series of questions or prompts. Some Sweepstakes may include additional optional engagement features—such as checking into a Live Drawing or confirming prize acceptance through an on-screen prompt—which will be described in the Sweepstakes Details. These additional steps, if required, relate only to confirming prize acceptance and do not affect eligibility to enter. Limit one (1) entry per person unless otherwise stated.
- **3.5. Entry Limit.** The use of automated devices or programs to enter the Sweepstakes is prohibited. Subsequent entries from the same eligible individual in excess of the entry limit will be automatically disqualified from the Sweepstakes. Any attempt by any person to obtain more than the stated number of entries will void all of that person's entries and that person will be disqualified. The Company shall not be responsible for

late, lost, delayed, damaged, misdirected, incomplete, illegible, mutilated, or unintelligible entries. Incomplete or illegible entries are not eligible and will be disregarded. Only entries submitted in accordance with these Terms are eligible.

- **3.6. Prior Winners; Waiting Period.** If an entrant is awarded any prize in a Sweepstakes, such entrant shall be ineligible to receive any monetary award in any subsequent Sweepstakes for a period of four (4) months from the date on which the prior prize was awarded. Entrants may submit entries to subsequent Sweepstakes during this waiting period; however, they shall not be eligible for selection for monetary awards only in-kind benefits (as defined below) until the waiting period has fully expired.
- **3.7. Sweepstakes Period.** The Sweepstakes will run for the period set forth in the applicable Sweepstakes Details (the "Sweepstakes Period").

### 4. Prizes and Selection Process.

- **4.1. Selection Process.** The selection process depends on whether the Sweepstakes is a "Live Drawing" or a regular drawing. During a regular drawing, the winner(s) for the Sweepstakes shall be randomly selected from among all eligible entries received during the applicable Sweepstakes Period (each, a "Winner"). The number of Winners that may be selected for each Sweepstakes will vary and will be specified in the applicable Sweepstakes Details. The odds of winning depend on the number of eligible entries received during the Sweepstakes Period.
- **4.2. Live Drawing Format (if applicable).** Some Sweepstakes may be conducted as a "Live Drawing," as described in the applicable Sweepstakes Details. During a Live Drawing, entrants may be required to: Check in during the Live Drawing window; and/or Confirm acceptance of a prize through an on-screen prompt or other mechanism communicated during the event ("Acceptance Action").

The specific requirements, if any, will be stated in the Sweepstakes Details and announced during the Live Drawing. Failure to complete the Acceptance Action within the time specified will be deemed a rejection of the prize, and an alternate potential winner may be selected. Participation in the Live Drawing is **not required to enter the Sweepstakes**, but may be required to accept a prize in a Live Drawing format. Completion of any Acceptance Action is required only to confirm receipt of a prize after random selection and **does not affect an entrant's odds of winning or eligibility to be selected.** 

**4.3. Prizes.** Prizes may consist of: (a) monetary awards, provided directly to recipients; and/or (b) in-kind benefits, which may include credits, services, or resources provided by the Company. The type and amount of each prize will be set forth in the applicable Sweepstakes Details and during the live drawing.

- **4.4. Winner Notification.** Winners will be notified by the Company via email using the email address associated with their Skip account.
- **4.5. Taxes.** Winners are solely responsible for any federal, state, or local tax obligations or other expenses associated with receiving a prize.
- **4.6. Restrictions.** No substitution, transfer, or assignment of a prize is permitted, except that the Company reserves the right, in its sole discretion, to substitute a prize of equal or greater value.
- 5. **Publicity.** By accepting a prize, each Winner grants the Company a non-exclusive, worldwide, royalty-free, perpetual license to use the Winner's name, likeness, biographical information, and submitted content for promotional, marketing, and Sweepstakes-related purposes in any and all media now known or later developed, without notice, review, approval or any additional compensation, except where prohibited by law.

#### 6. Additional Terms.

- **6.1. Cash Prize Requirement.** Payment of any cash prize is conditioned upon the Winner setting up a valid payment account with the Company's third-party payment processor and completing all required onboarding steps in accordance with the Company's <u>Terms of Use</u>. No cash prize will be disbursed until all such requirements have been fully satisfied.
- **6.2. Referral Incentives.** From time to time, the Company may offer referral incentives in connection with a Sweepstakes (e.g., awarding a bonus amount to an entrant who referred a Winner). Any such referral incentive is supplemental, is separate from the primary prize awarded to a Winner, and does not affect any entrant's eligibility, entry limits, or odds of winning the Sweepstakes. Details of any referral incentives, if offered, will be provided in the applicable Sweepstakes Details.
- **6.3. Modification or Cancellation.** If, for any reason, the Sweepstakes is not capable of running as planned, the Company reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Sweepstakes. Any such changes will be posted on the Company's website.
- **6.4. Technical Issues.** The Company is not responsible for any technical difficulties or failures that may affect participation in the Sweepstakes, the ability to submit an entry, attendance at a Live Drawing, completion of any required Acceptance Action, or the receipt of notifications. These difficulties may include, without limitation, network outages, server failures, browser issues, device malfunctions, delays, disconnections, or other technological problems of any kind. The Company reserves the right to disqualify any entry or rescind any prize affected by such technical issues in its sole discretion.
- **6.5.** Compliance. Entrants must comply with these Terms, the applicable Sweepstakes Details, and all applicable laws.

- **6.6. Grounds for Disqualification.** The Company may disqualify any entrant who, as determined by the Company in its sole discretion:
  - (a) violates these Terms or the Sweepstakes Details;
  - (b) provides false or misleading information;
  - (c) engages in fraud or misconduct; or
  - (d) engages in conduct that the Company determines is harmful or inconsistent with the spirit of the Sweepstakes.
- 7. LIMITATION OF LIABILITY. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL THE COMPANY OR ANY OF ITS PERSONNEL BE LIABLE FOR ANY SPECIAL, INCIDENTAL, CONSEQUENTIAL, STATUTORY, EXEMPLARY, PUNITIVE OR OTHER INDIRECT DAMAGES OR FOR ANY LOSS OF PROFITS, LOSS OF DATA OR LOSS OF USE DAMAGES, OR DEATH OR BODILY HARM, RELATING TO THE SWEEPSTAKES, ANY PRIZE, OR THESE TERMS, EVEN IF SUCH PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, YOU AGREE THAT THE COMPANY'S AND ITS PERSONNEL'S MAXIMUM AGGREGATE LIABILITY RELATING TO THE SWEEPSTAKES, ANY PRIZE, OR THESE TERMS WILL NOT EXCEED ONE HUNDRED U.S. DOLLARS (\$100). THE PRECEDING LIMITATIONS SHALL APPLY TO ANY AND ALL LIABILITIES OR CAUSES OF ACTION HOWEVER ALLEGED OR ARISING, INCLUDING, BUT NOT LIMITED TO, NEGLIGENCE, BREACH OF CONTRACT, OR ANY OTHER CLAIM, WHETHER IN TORT, CONTRACT, OR EQUITY.
- 8. Indemnity and Release. By participating in the Sweepstakes, you on behalf of yourself and your heirs, executors, and administrators, agree: to release, defend, indemnify, and hold harmless the Company from and against any and all claims, lawsuits, judgments, causes of action, proceedings, demands, fines, penalties, liabilities, costs and expenses (including, without limitation, reasonable outside attorneys' fees) that may arise in connection with: (i) your participation in the Sweepstakes or use of any prize; (ii) typographical, technical, or printing errors in these Terms or the Sweepstakes materials; (iii) any change in a prize, including due to unavailability or reasons beyond the Company's control; (iv) any interruption, postponement, cancellation, or modification of the Sweepstakes; (v) human error; (vi) any wrongful, negligent, or unauthorized act or omission by the Company or any third party; or
  - (vii) your violation of these Terms.
- 9. **Governing Law; Dispute Resolution.** These Terms shall be governed by and construed in accordance with the laws specified in the Company's <u>Terms of Use</u>. Any disputes arising out of or relating to the Sweepstakes or these Terms shall be resolved in accordance with the dispute-resolution provisions set forth in the Company's <u>Terms of Use</u>.
