Sustainability affects us all: our residents, our businesses, our clubs, our communities, our guests and nature.

#### Sustainability Strategy We must

act responsibly towards our natural environment, our resources, and our society to create a livable environment. With the development of the sustainability strategy for the Zermatt, Täsch, and Randa living space, a foundation has been laid for placing greater emphasis on the sustainable development of the inner Matter Valley . This will ensure that "this area of Zermatt remains livable now and for years to come."

To be able to offer a variety of activities in our living space , create unique experiences, and simultaneously serve as a place for the population, we need intact nature (ecology), a strong economy (economics), and committed people (social). Only when all three areas intertwine and complement each other can our living space be livable. When all three levels converge, we speak of sustainability.



Sustainability is not a trend for our living space in Zermatt, Täsch, Randa.

"Sustainable development is development that meets the needs of the present without compromising the ability of future generations to meet their own needs." (Brundtland Report 1987)

It is a way of life that requires everyone to take responsibility: the communities, our residents, the various organizations, service providers and our guests.

#### Initial situation

As part of the Zermatt Destination Strategy, the Sustainability Subgroup was launched to advance the topic of sustainability within the Zermatt - Matterhorn destination . In 2019, various service partners of the destination met for a workshop to develop, among other things, the areas of action and the organization of the Sustainability Subgroup .


In July 2021, the Zermatt Strategy Group submitted a request to the Zermatt Municipality (EWG) to advance the topic of sustainability in Zermatt in a coordinated manner. According to the request dated July 30, 2021, Zermatt "can, if it so desires, become a beacon of sustainability—not only as a tourist destination, but also as an alpine habitat for future generations."

The EWG decided to take responsibility for this issue and develop a sustainability strategy for the municipality of Zermatt. The municipalities

Täsch and Randa were invited to participate.

The three communities are closely linked at various levels and the topic of sustainability is also relevant in the promotion and development of the Inner Matter Valley.

To ensure the most holistic approach possible, the EWG has established the Zermatt Sustainability Office and identified organizations and individuals who will participate in a working group to develop the sustainability strategy. This will ensure the broadest possible coverage of stakeholders in the three municipalities and bring the sustainability strategy to life during the implementation phase, ensuring that it does not remain merely a strategy paper.



#### Development and implementation of the sustainability strategy

Over the past two years, more than 20 people (see working and steering group) have met regularly to develop fields of action, goals, and a basket of measures (as inspiration for the implementation phase) for our living space . Starting in 2024, this committee will meet four times a year to exchange ideas and advance the implementation of the sustainability strategy. The Sustainability Office provides support in this

The ten fields of action, with their respective overarching qualitative objectives, form the framework for orientation. For each field of action, one or more topic leads (committees /commissions) have been defined, each focusing on one or more fields of action. One member of the committee forms

The link between the committee/commission and the steering group. The steering group meets four times a year to discuss progress and gather ideas to advance the implementation of the sustainability strategy . Furthermore, the members of the steering group also serve as the interface to the organizations and stakeholders in the Zermatt, Täsch, and Randa region.

Various committees/commissions will be informed and involved over the next few weeks. It is now up to them to implement the defined measures and contribute new ideas within the framework of sustainability. To ensure that the developed sustainability strategy is implemented throughout the entire destination , one goal is to also anchor the topic of sustainability in the destination strategy. The next steering group meeting will take place in March 2024.

Special transports in connection with early construction site installation require approval.

The transport of excavated and demolition material Whit Monday: Monday, May 20, 2024 Construction work with trucks or vehicles with combustion engines requires a permit. Construction companies are required to collect the relevant permit plates from the Public Safety Department and display them clearly in their vehicles.

#### 4-axle truck / weight

During the excavation period, 4-axle trucks can also be used for used to transport excavated and demolition material - with a maximum weight of 30 t.

The use of dumpers is both subject to approval and subject to authorization. The use of a dumper is only permitted upon a substantiated application

In general, activities and work on mobile or stationary installations are permitted on weekdays from 7:30 a.m. to 12:00 p.m. and from construction sites along the route, provided space permits (no public 1:00 p.m. to 6:30 p.m. On Sundays and

Motor vehicle traffic, the use of construction machinery, and drilling, blasting, and excavation work are generally prohibited on public holidays and other restricted days.

The following construction machinery may only be used during excavation periods in spring and fall: pneumatic loaders, excavators, bulldozers, compressors, jackhammers, and other heavy construction equipment. The permitted operating hours for these machines and equipment are: 7:30 a.m. to 12:00 p.m. and 1:00 p.m. to 6:30 p.m.

#### Excavators up to 5 t

Excavators with rubber tracks or tires up to 5 t may be used all year

#### Helicopter flights for material transport

Helicopter transport of materials within the village is permitted only during the construction seasons in spring and fall. For overflights within the village, an application for an overflight permit must be submitted to the Public Safety Department.

## Workshop Poetry Slam & Slam Reading Stage




Writing – touching – performing: Poetry slam is lively, gets under your skin, makes you laugh and cry.

## Precarious parking situation

## How the municipality of Zermatt (EWG) intends to counteract the problem

In October 2022, the information and exchange event "Traffic in Zermatt" took place in the Triftbachhalle.



This event met with great interest from the public, and many participants were welcomed. During lively discussions on various topics related to traffic in Zermatt

The unsatisfactory parking situation was addressed. A particular topic was socalled "wild parking" in narrow and confusing street sections, as this poses a significant risk of accidents.

The municipal traffic regulations (VR) require each vehicle operating in Zermatt to have its own parking space, where the vehicle is parked when not in use. The majority of parking spaces for vehicles operating in Zermatt are located at the respective businesses or in the parking garages in Spiss. Parking the vehicles in the designated parking spaces is therefore often not feasible. Employees and materials travel to a customer in a vehicle . There, everything that is needed and could be needed must be unloaded and the vehicle returned to the parking lot. If something is missing, an employee must walk to get the vehicle, drive to the warehouse or transfer point, and then return to the customer. Parking vehicles in the designated parking spaces is not always practical, which is why it is not implemented. The EWG sees two options for counteracting this problem.

#### Parking spaces on public land

The EWG has already conducted a preliminary assessment and determined that approximately 20 parking spaces could be created on public land . However, some of this land is located on areas with low parking demand, making it impractical. The remaining areas will be assessed over the next few months for their suitability as parking spaces to alleviate the situation.

#### 2. Parking on private property

A second option, which requires public cooperation, is parking on private land. Perhaps there are citizens willing to donate a piece of their private land for the construction of a parking lot, in places where the EWG cannot provide public land for use. The EWG welcomes any landowner willing to discuss this topic. The only requirement currently is that the land to be offered is located on a public, accessible read or path.

## Emergency meeting points

Based on a national concept, the Canton of Valais is introducing emergency meeting points (NTP) for disasters or emergencies throughout the canton.

#### In Zermatt, 6 NTPs were defined: These are for the majority of

Easily accessible to the population on foot or by bike:

- · NTP1: Church Square / Community Center
- NTP2: Station Square
- · NTP3: Parking Urania
- · NTP4: Wiesti (intersection of Wiestistrasse / Gryfelblatte)
- · NTP5: Winkelmatten Chapel
- NTP6: Furi / Station ZBAG

The Emergency Meeting Point (NTP) is your point of contact in the event of an incident (such as an earthquake, blackout, or prolonged communication outage). You will receive emergency support and important information about the situation on site there. If you need help or can offer help yourself, the Emergency Meeting Point serves as a hub. In the event of a prolonged power outage with a loss of telecommunications, you can contact the Emergency

You can also make emergency calls at this meeting point. You can find out which emergency meeting points are open at what time via the radio or the Alertswiss app. The open emergency meeting point is easy to find in the event of an emergency; it is marked with a flag. #### Instructions for behavior

To be prepared in the event of an emergency, the canton has issued various guidelines for action, such as avalanches, floods, or earthquakes. These are available at www.vs.ch/










#### How can you prepare?

The Cantonal Department for Population and Migration (DBM) introduced the new "GestStar" software for processing residence permits for migrants in September 2023. In a December 2023 press release, the DBM announced that the chronic backlog in processing applications had been resolved and that new organizational and procedural measures had been put in place.

### Abolition of adhesive labels in voting

and elections The Council of State has amended the regulations on postal voting: the requirement that postal voters affix their self-adhesive label to the return form has been abolished. This change will take effect on

February 1, 2024, and will apply to the next vote on March 3, 2024.

Due to electoral fraud in the cantonal elections of March 2017, the State Council took an additional measure to increase the security of mail-in voting: it introduced the personal self- adhesive label. Each eligible voter received a set of personal, selfadhesive labels. During a ballot, the mail-in voter had to affix their label to the return form in the designated box; otherwise, their vote was invalid

On the occasion of the November 2023 session of the An urgent motion was submitted to the Grand Council requesting an amendment to the Ordinance on Postal Voting (VbS-tA) - specifically, the immediate abolition of the self-adhesive label . The State Council endorsed the arguments of the motion, especially since the self-adhesive label may have contributed to the decline in voter turnout.

Following this urgent request, the State Council amended the regulations on postal voting and abolished the requirement that postal voters must

affix their self-adhesive label to the return form.

# Goodbye Walka 3 schoolhouse «Niww Walka» – here we come!

After 52 years, the Walka 3 school building is now history
—abandoned and empty, the classrooms cleared

out, and the children and their teachers gone. The school building continued to operate during the phased construction of the new building. 200 students in Cycle 2 (5H–8H) attended classes there.

The last day of school at "Walka 3" took place on January 22, 2024. The students have moved and are now being taught at "Niww Walka."

## Walka 3: The school building of the orientation school Classes were held in the parish hall until 1959. In the autumn of -

In the same year, Zermatt schoolchildren moved into the newly built Walka 1 and 2 school buildings, accompanied by a new feature: a gymnasium! 184 students attended primary school, 17 attended home economics school, and 14 attended secondary school. Class sizes were 37-40 children, and classes lasted eight months.

The secondary school had to be closed temporarily, and the six students attended in St. Niklaus. In 1963, the community ventured

Zermatt, Täsch and Randa the reopening of a secondary - school, the home economics school, and the final classes continued. At the beginning of the 1970s, student numbers continued to rise.

#### The «unbundling»

Zermatt's schools have grown steadily. 650 schoolchildren were which was taught in the Walka 1 – 3 school buildings, in the Im Hof school building, and in the Trift school building. A huge and sometimes confusing coexistence developed: 120 kindergarten children and 40 primary school students attended classes in the Im Hof school building. In addition, there were many

secondary school students who studied technology in the same school building. or textile design, sports, and home economics . The different break and lesson times, the

division of school classes into different buildings and the «through-The "mixing of children" in the individual school buildings created problems over time

Already in the school year 2010/2011, the school administration was looking for possiopportunities to unbundle the school operations, especially since various rooms were to be converted with interactive whiteboards and, as part of the introduction of the new timetable for orientation -

suitable premises for the subject of science and technology had to be made available to the school. Furthermore, there was also the opportunity to renovate rooms that had accumulated over the years -

to dispose of waste material and to use and utilize the premises more efficiently.

In June 2012, the big move began: The orientation school moved from wings 2 and 3 (Walka school building) to the Trift and Im Hof school buildings, the kindergarten moved into the seven rooms in wing 2 (Walka school building), the 3rd, 5th and 6th grades were taught in wing 3 (Walka school building) and the 1st, 2nd and 4th grades in wing 1 (Walka school building).

The move at the end of school went well, with 67 school rooms and their contents were moved, 60 desks and 100 PCs were moved, 23 in interactive wall panels were installed and 7 tons of material were disposed of.

#### Temporary Walka 3

From 2012 to 2021, Cycle 2 students attended classes in Walka 3. In the Walka 1 and

2, the children of Cycle 1 learned. In February 2021, with the new building of Niww Walka (Phase 1) in the starting blocks, the classes in Walka 3 moved closer together and all rooms were occupied to their maximum capacity. The playground was no longer available, and a new building was built between the school building "Im Hof" and the Brunner-Lauber-Haus.

additional space was created. The 11 classes of Cycle 1 moved into the school provisional in the Oberen Matten.

#### January 2024: Move to d'Niww Walka

On January 22, 2024, the time had come – the classes of 4H – 8H

moved into the "Niww Walka." This allowed preparations for the demolition of Walka 3 to begin on time. The children in grades 1H/2H and 3H will remain in the temporary building until the third building is ready for occupancy in August 2025. The ground floor will house a daycare center, while the kindergarten and grade 3H will occupy the upper floors.

For weeks, teachers and their assistants have been disposing of their materials, moving, and setting up the new classrooms. On January 22, 2024, teachers and children, the library team, and the school administration cleared out the remaining rooms of "Walka 3" and packed books and school supplies into boxes.

The classrooms and specialist rooms were cleared out, timetables were moderately adjusted. Teachers were instructed on how to use the new "blackboards," and school operations are picking up speed:

"Bye Walka 3 – Hello Niww Walka!".

#### Changes to communities of heirs from the 2023 tax period

Starting with the 2023 tax period, the heirs of the deceased taxpayer must file an inheritance tax return for undistributed inheritances. This is only possible using the VSTax software solution.

This affects all inheritance communities of single persons who died in 2022 and 2023. Existing inheritance communities from

2021 and earlier will also be converted in stages over the next few years .

Taxing the community of heirs as a single taxable entity until dissolution will no longer be possible in the future. A detailed breakdown of income from undistributed inheritances or other assets must be attached to the tax return.

#### Allocation of income and assets: Please note that the

executor should inform the members of the undistributed estate of the allocation (page 3 of the new inheritance tax return) of the income and assets, which each member must declare in their tax return

Anyone who makes their own or rented property available for payment must declare the resulting income for tax purposes. This includes, in particular, income from online platforms such as Airbnb, Booking.com, etc.

Records of income and expenditure must be attached to the tax return and declared under heading 1110, even if the tenants are permanent tenants.

#### VSTax 2023

We recommend that everyone use the free VSTax 2023 software at www.vs.ch/vstax to complete their 2023 tax return. This software has been adapted and improved for the 2023 tax period. The website www.vs.ch/steuern contains the "Online Assessment Guide" with all instructions and content on assessment practices, the tax calculator for calculating all types of taxes, and much other information on taxation.

The Cantonal Tax Administration will begin sending out the 2023 tax returns at the beginning of February 2024 .

The deadline for filing the 2023 tax return is March 31, 2024.

The form "Application for subsequent ordinary assessment" (NOV) for persons with a B permit must also be submitted by March 31, 2024!

It is important to note that these individuals must subsequently file a tax return every year. Once a tax return has been applied for, it cannot be withdrawn.

### Installment tax payments 2024

The 2024 installment payments were sent at the end of January or beginning of February 2024 and are intended for the payment of taxes in installments and are levied in accordance with Article 193 of the Tax Act. These advance payments are to be paid within 30 days of the due dates listed below:

st installment February 10, 2024

2nd installment April 10, 2024 3rd installment June 10, 2024

4th installment August 10, 2024

4th installment August 10, 2024 5th installment October 10, 2024

In the final tax settlement for 2024, the amounts paid will be credited to the corresponding tax year. Interest will be calculated as follows:

Any amounts overcharged and paid will be subject to interest at a rate of 3.5% in the final settlement.

 $\cdot$  The default interest for unpaid or late payments is also 3.5%.

As in previous years, no interest credits can be granted for advance payments of tax withholdings in 2024 .

• The negative compensatory interest for outstanding amounts will be demanded in accordance with Article 164 paragraph a of the Tax Act with the final settlement from the general due date of taxes, March 31, 2025, and charged at 3.5% if the interest amount exceeds CHF 500.



Taxpayers who have made insufficient advance payments are advised to make a supplementary payment in order to avoid the compensatory interest.

Taxpayers who have not received any invoices for advance payments in 2024 but have an annual income of more than CHF 35,000 are requested to contact the Tax Office.

#### Outlook for the 2024 tax period

At the Grand Council meeting on December 14, 2023, it was decided to increase the indexation of cantonal taxes from 164% to 165%. This means that cantonal taxes will be slightly lower starting with the 2024 tax period.

In March 2024, the Grand Council will again discuss a revision of the tax law. Any changes would also result in a further reduction in taxes.

## Waste management – disposal of kitchen waste



Waste is full of valuable

materials and energy. They are the raw materials of the future. This res-

resources must be used optimally and in clean to keep them in clean cycles. Municipal waste

regulations govern the disposal of various recyclable materials.

For example, kitchen waste is collected separately and processed into fertilizer or to generate electricity at the local biogas plant in Zen Stecken.

#### Incorrect disposal from private households

In recent months, it has become increasingly apparent that a large number of improper disposals are taking place in the containers provided for kitchen waste disposal. In addition to plastic, PET bottles, and cutlery, glass, cardboard, and other waste are also being disposed of in them.

#### Problem

In the local biogas plant, such foreign bodies then enter the processing process and sometimes even damage the plant, leading to downtime and high repair costs.

Due to the high number of improper disposals, Zermatt Waste Management is currently examining various measures to improve the quality of kitchen waste collected at public collection points. In addition to a communication campaign, more frequent inspections and subsequent reports are being implemented.

We hope that we will be able to continue to offer the collection of kitchen waste at public waste disposal sites in the future.

The finance department of the municipality of Zermatt was reorganized as of 1 March

The Finance Department has proposed a reorganization to the municipal council that redefines the department's responsibilities. Diego Kronig has taken over as head of the Finance Department, and Corinne Schuler, registrar, has been appointed as his deputy. The Finance Department has its offices on the first floor of the municipal building and is staffed by nine employees.

#### Head of Finance

Diego Kronig is the contact person for budgeting, annual financial statements, and financial planning. Liquidity planning and all payments are also handled by him. He is responsible for managing the event pool and the infrastructure fund. In addition to managing the department's personnel, his responsibilities also include social services and acting as deputy to the Registrar's Office

#### Registrar / Deputy Head of Finance Department

Corinne Schuler works as a registrar and as deputy head of finance. The registrar's office encompasses an exciting and varied range of responsibilities. Here, transfers of ownership are recorded, changes are recorded, cadastral extracts are prepared, information is provided by telephone and in writing, and much more. In her role as registrar, she is a member of the Valuation and Surveying Commission. applications.

Thomas Graven is responsible for financial accounting and payroll accounting. His core responsibilities include managing the general ledger, including closing procedures, managing payroll accounting, responsibility for personnel and social security contributions, managing the main cash register and postal and bank accounts, processing VAT returns, and providing support with budgeting and financial planning.

#### Accounting clerks

Simona Stojanovic works as a finance clerk and also serves as the deputy head of the accounting department. She is responsible for accounts payable and accounts receivable management for the municipality of Zermatt (EWG), debt collection and dunning, as well as providing support with the annual financial statements and budgeting. Her deputy role also includes assisting with maintaining the general ledger.

Rita Stojanovic works part-time (50%), and Patrizia Sarbach works part-time (40%). Rita is primarily responsible for accounts receivable management and assisting with accounts payable administration. Patrizia's responsibilities include processing accounts payable invoices, preparing accounts receivable invoices, and supporting payroll accounting . Telephone and counter service, as well as supervising trainees, are also part of her daily work.

#### Finance department clerk / AHV branch

Gerhard Karlen is responsible for the registration, monitoring, changes, and invoicing of fee-paying subscribers in the waste, water, and wastewater sectors. He is also responsible for the AHV branch office. Advising the public at the counter and by phone is time-consuming and highly valued. This also includes processing and monitoring AHV

## **Head of Tax Department**

Natalie Julen is primarily responsible for municipal tax collection. This includes the timely dispatch of advance payments, as well as the invoicing of provisional and final statements and special taxes such as capital gains and liquidation gains.

Tax budgeting and the annual financial statements are prepared in cooperation with the Head of Finance.

She is also responsible for the insurance system of the municipality

#### Tax / Accounting Clerk

As a clerk, Esther Walker is responsible for assisting with tax collection, tax changes, and municipal tax invoicing. Her responsibilities also include assisting with accounts payable and acting as a deputy for garbage and water billing

## Municipal judges and municipal deputy judges

The law governing the organization of judicial authorities provides for the election of a municipal judge and his deputy for each municipality – this also applies to the municipality of Zermatt. In the current legislative period (2021-2024), Roman

Henzen serves as municipal judge and Fabian Imboden as deputy municipal judge.

Municipal judges and their deputies are not professional magistrates. Their election is governed by the cantonal constitution and the law on elections and referendums. However, it is possible for two or more municipalities to have the same municipal judge and/or deputy municipal judge.

#### swearing-i

The municipal judges and their deputies are sworn in by the district judge, who serves as their supervisory authority. The municipal judge is assisted by a court clerk who has legal training and serves in an advisory capacity.

#### Arbitration

Conciliation is the most important activity of the municipal judge. Subject to differing legal

According to legal provisions, civil proceedings are initiated by holding a reconciliation session before the municipal judge.

If no conciliation can be reached, the powers of the municipal judge are limited . At the request of the plaintiff, the municipal judge can instruct and decide on property disputes with a value in dispute of up to CHF 2,000. In property disputes with a value in dispute of up to CHF 5,000, the municipal judge can issue a preliminary ruling.


#### Further tasks and competencies

In addition, the municipal judge has several powers in the area of voluntary jurisdiction. In particular, they are responsible for pronouncing wills and inheritance contracts, taking measures to secure the inheritance (inventory and sealing of the inheritance assets), and issuing certificates of inheritance.

However, the municipal judge is not responsible for, among other things, rental disputes (responsibility: Cantonal Arbitration Commission for Tenancies) or disputes relating to an employment relationship (responsibility: Cantonal Office for Employee Protection and Employment Relationships).



#### From the survey

The survey was conducted last year in the Randa, Täsch, and Zermatt regions . 138 people of all ages participated. 51% of participants were between 0 and 15 years old. 20% were between 36 and 50 years old. The survey also asked about the popularity of the clubs; some clubs were known to half of the respondents. Unfortunately, the majority of the 94 clubs were known to less than half of the respondents. The respondents' willingness to travel was also assessed: 81% could imagine a travel time of more than 16 minutes, and 48% could even imagine a travel time of more than 30 minutes. ## Media education for children and young people School social work Inneres Mattertal promotes a responsible use of media

In an increasingly digitalized world, competent media skills are crucial for children and young people. The school district and school social work department of the Inner Matter Valley are actively committed to strengthening the media skills of children and young people and teaching them the skills to use media responsibly.

Today's youth have grown up in a world where digital media occupy an integral place in everyday life. From social media to online games to online schoolwork – children and young people are constantly surrounded by various media. To prepare them for the challenges of this digital world, the school region and school social work in the inner Matter Valley focus on targeted media education.

In recent years, the prevention project was introduced and successfully implemented. The goal is not only to train children and young people in the use of digital media, but also to promote their media skills. This

includes critically questioning information and images.

conscious use of social media, rights in the digital space, respectful interaction even in virtual worlds, and the promotion of creative possibilities on the Internet.

Through age-appropriate, playful, and practical project sessions, students in grades 3H–11 OS are introduced to key topics in the spring and actively involved in working on them. We place particular emphasis on the critical, yet child-friendly use of digital media. To support media use during leisure time and to provide opportunities for media-free leisure time, the youth work center of the Inner Matter Valley is involved in the upper grades.

Not only is school support and guidance in the area of media education important, but parental involvement also plays a crucial role in promoting the media literacy of children and young people. It is important that parents take an active role in promoting responsible and competent use of digital media.

Parents and guardians play a valuable and important role in supporting children and young people in the digital world and helping them to see and understand risks and opportunities.

Parents can explore digital worlds together with their children and combine education with fun. This not only promotes

the bond between parents and children, but also enables the teaching of media skills in a positive way.

Parental involvement in media education is crucial for promoting children 's positive development in a digitalized world and enabling them to use media responsibly.

Collaboration between parents , the school, and school social workers is crucial to providing the best possible support for children. To also train parents in media education, age- and topic-specific parent evenings are held. Parents will receive more information about this in due course.

## Agriculture in Zermatt over time

Zermatt – to the mat/
Prato Borni – has always
been a farming village.
In the Middle Ages it also
served as a small
Transshipment point and
stopover on the trade route

over the Theodul Pass –
then called Matterjoch
or Augst Pass – into the Augst
Valley (Aosta Valley) and
over the Eringer Pass into
the Rhone Valley.

Our ancestors not only settled in the valley floor, but also cleared the slopes and made them suitable for agriculture. The mountain communities of Findeln, Ried, and Aroleit, as well as the Stafel and Rifelalpe, are large areas of clearing. In addition, individual smaller forest patches were converted into meadows, for example, in the areas of Schweigmatten, Moos, Teifumate, Brandbode, Äbi, Riiti, and the remote Arsche.

At the beginning of the 19th century, agriculture was the sole source of income for the population. The importance of owning even a small estate can be seen in the story of Moritz Sigrist, born in 1791, who participated more or less voluntarily in Napoleon's Russian campaign (1810–1812) for another Zermatt resident.

The community promised him a small cornfield on the Pudel, a rocky outcrop above the Bodmen, which he received upon his return after an 18-month absence. A barren field that has now lain fallow for generations. Thus, everyone worked in mountain farming; other sources of income were practically nonexistent. A good hay and grain harvest was the prerequisite for a modest prosperity for large families. Zermatt boasted extensive alpine pastures, a large meadow and pasture area, and numerous grain fields and potato fields, which ensured self-sufficiency. However, farming was not profitable.


#### Change in the 20th century

The importance of agriculture has changed fundamentally over the course of this century in Zermatt, as elsewhere in Valais. At the beginning of the 20th century, the population grew again, and providing for families became more difficult, so many men sought work outside the village during the winter. The majority of the village continued to work in agriculture, although Zermatt already had around 600 guest beds at the turn of the century. It wasn't until the Visp-Zermatt railway began year-round operation at the end of the 1920s, and with it the rise of winter sports, that quite a few found tourism as an additional source of income. As a result, several families gave up livestock farming.


Today, farming has become a secondary occupation. Although the number of mountain farmers is small, thanks to them, almost all the meadows in the immediate vicinity of the village are still mown, thus making an important contribution to our environment.



## Felix Julen – Harem Pants

Felix Julen was a resident of the "St. Mauritius" in Zermatt for some time. He began with great joy to describe the

intense events from his life as a mountain guide. Sadly, he passed away before completing his complete account.

With the help of his son Jörg, this impressive report was nevertheless able to be written.

An impressive experience – crash on

the Lyskamm

"One of my uncles ran a hotel at the time . He was hosting a guest who wanted to cross Monte Rosa and Lyskamm. We met at the train station and then climbed together to the Monte Rosa Hut. When I saw him, I was startled. He had equipment, but he was wearing mountaineering pants that were much too big. They were 'harem pants,' which we called 'knickerbockers' back then.

At the start of our tour, I told him that I found his pants unsuitable and dangerous.

The next morning, we set off early. It was a beautiful day with a very strong north wind. We climbed the east ridge to the Lyskamm, with me constantly monitoring my guest and leading him on a short rope. We crossed the ridge to reach the east summit from the west summit. The ridge between the two summits consisted of absolutely bare ice on the north side. Since I had to hack steps.

It was no longer possible to use the short rope there. I always went half a rope length ahead. This way, I was about 15 meters ahead of the guest, hacked a step, and then let him follow. I watched him closely and saw how, after the first few steps, he got stuck with his crampons on his "bag pants."

He then fell headfirst down the north face. This happened at a point where the north face was about a thousand

Meters vertically and steeply down to the Grenzgletscher. Fortunately, I was able to stop my guest, who was now swinging over the ice wall. I called to him to use his ice axe, which he had fortunately been able to hold, to hack a step so he could stand on it. However, this was impossible for him at foot level. I was afraid he might damage the rope and fall again. There was no one around who could have helped us. No one was climbing up from the Sella Hut; no one had started from the Marguerita Hut, and no one was coming from the Gnifetti Hut either. I was completely alone.

with the guest in this very dangerous situation. It was very cold and a strong north wind was blowing.

Finally, I gathered all my strength and pulled him up, repeatedly wrapping the rope around my own arm and wrist. After preparing an even larger belay with my ice axe, I handed my adjustable crampons to the guest. The guest hadn't said a single word during this operation. He was probably unaware of the dangerous, lifethreatening situation. We then continued to the West Summit, descended to the Felikjoch via the Twin Glacier, then headed back toward the Monte Rosa Hut and Rotenboden. Late in the evening, we reached Zermatt on the last train. The shock set in during the night, and he needed medical attention. Only then did he begin to realize what could have happened and that his "harem pants" had almost cost him and me our lives.







Felix was already interested in climbing in primary school. An excerpt from one of Felix's school assignments: "The chamois has a slit in its hooves to help it climb."

Loosely translated: "The chamois has split hooves so that it can climb better."

After the Second World War, he completed mountain guide school and subsequently


