## 2. ADDITIONAL INFORMATION ON DATA PROTECTION

The present Privacy Policy regulates the processing of the data collected by CARSHARING AND MOBILITY SERVICES, FRANCE (hereinafter, the **Company**) through the Application (hereinafter, the **App**) and/or the Website within the framework of the provision of the multi-user carsharing service within an operational area, subject to the availability of the vehicles, offered by the Company (hereinafter, the **Service**). This Policy forms an integral part of the General Terms and Conditions of Use. The Company recommends the User to read our Privacy Policy carefully.

ATTENTION: This Privacy Policy is therefore not applicable to the processing of personal data collected in the context of vehicle rental and the associated car-sharing services provided by ZITY France when they are reserved from the FREE NOW application. The processing of data resulting from these reservations is carried out within the framework of personal data processing implemented jointly by ZITY France (whose address is specified below), and the companies Transopco France SAS and Transcovo SAS (having as the common address 4 place du 8 mai 1945, 92300 Levallois-Perret, hereinafter together “FREE NOW”). In accordance with the regulations, this joint processing of personal data is governed by a contract of joint responsibility concluded between the joint controllers, under the terms of which Zity France is more particularly in charge of the processing with regard to matters relating to the rental of vehicles and car-sharing, and FREE NOW technical aspects related to the use of the FREE NOW application, in particular payment for transactions. This contract provides that the information due to users of the FREE NOW application is provided by FREE NOW. Similarly, without calling into question the right of users to exercise the rights conferred on them by the regulations with regard to and against each of the joint controllers, in order to simplify the exercise of these rights, users of the FREE NOW application are invited to exercise them with FREE NOW which they use for their reservations. All the information on this joint processing is available in the FREE NOW privacy policy.

The User guarantees that the information provided is true, accurate, complete and up-to-date, and is liable for any damages, direct or indirect, that may arise from failure to comply with this obligation. When the User provides personal data relating to third parties, he/she guarantees that he/she has informed them of the content of this Privacy Policy and that he/she has obtained their prior consent to provide us with their personal data or has another valid legitimate basis.

The Company reserves the right to request documentary evidence of compliance with this obligation.

In relation to the personal data requested through the forms provided in the App, it will be necessary for the User to provide at least those marked with an asterisk, since, if this data, considered necessary, is not provided, the Company will not be able to accept and manage the request.

The Company may amend this Privacy Policy from time to time. In the event of a change to the Privacy Policy, we will notify you via the App, our website or by any other means of communication to ensure that you are informed of the new privacy terms applicable to the Company's Services. Your continued use of the Services after we have informed you of changes to our Privacy Policy will mean that you agree to the new terms, except in relation to possible data processing purposes where your consent is required.

## For what purpose do we process the personal data of the user and with what lawful basis?

The personal data that the User provides to us may be processed by the Company for any of the purposes detailed below, depending on the type of data provided to us and the interactions that the User performs through the Service:

### 1. User management:

- **Purpose:** Provision, management, optimisation, personalisation and monitoring of the Service, as well as provision of assistance to the User. Identification of the user and verification of compliance with the necessary requirements for the rental of vehicles without a driver.
- **Data processed for this purpose:** Identifying and contact data; Economic, financial and insurance data; Transactions of goods and services; Other categories of data; Data derived from the use of the service.
- **Lawful basis for processing:** Performance of contract.

## 2. Transactional management:

- **Purpose:** Management of collection, payments, non-payments, invoicing, claims, accidents and administrative infringements. And, in general, any type of transactional management necessary for the provision of the service. In connection with the management of the Service's payment gateway, the data may be transferred internationally to a processor located in the USA (PayPal, Inc.), which provides appropriate contractual guarantees on the basis of European regulations. If you choose the option to save your payment (card) data, we inform you that your payment data will be retained and will be auto-completed for subsequent rentals, so that you do not need to enter your payment data for each new process, and they will be considered valid and valid for subsequent rentals. The card's security code (CVV or CVC) will only be used for the current rental. Users may modify or delete their cards at any time through the My Account - Payments and Promotions section.
- **Data processed for this purpose:** Identifying and contact data; Economic, financial and insurance data; Transactions of goods and services; Other categories of data; Data derived from the use of the service.
- **Lawful basis for processing:** Performance of contract.

## 3. Customer and consumer service:

- **Purpose:** Attention to requests, complaints, suggestions or claims related to the provision of Carsharing services.
- **Data processed for this purpose:** Identifying and contact data; Other categories of data.
- **Lawful basis for processing:** Performance of contract.

## 4. Profiling with internal sources:

- **Purpose:** In order to send Users personalised commercial communications adapted to the needs, preferences and personal circumstances of the Users, the Company may collect information on the use of the Services by a User, exclusively with internal data, as well as analyse the characteristics or behavioural patterns of the User, in order to predict their behaviour with regard to the use of Services. Profiling with data from internal sources may include the execution of operations that allow the optimisation of the provision of the Services of the App and the improvement of the quality of the same and, as a consequence, users receive commercial communications of one type or another depending on said analysis.
- **Data processed for this purpose:** Identifying and contact data; Personal characteristics; Transactions of goods and services; Other categories of data; Data derived from the use of the service.
- **Lawful basis for processing:** Legitimate interest of the Company in improving our commercial offer by providing our customers with products and services adapted to their personal characteristics and preferences. In this regard, the consequence of this exercise is the offer of products and services tailored to what the Company considers may be of interest to you. ## 5. Data analysis operations:

- **Purpose:** Based on the consent of users, the Company may perform analysis and data analytics operations in relation to user activity, as well as profiling with data from external sources in order to improve the quality of the Service, including predictive and mobility modelling.
- **Data processed for this purpose:** Identifying and contact data; Personal characteristics; Social circumstances; Academic and professional data; Commercial information; Transactions of goods and services; Economic, financial and insurance data; Other categories of data; Data derived from the use of the service.
- **Lawful basis for processing:** Consent of data subject.

## 6. Compliance with the Company's legal obligations in relation to the Carsharing and Mobility Services:

- **Purpose:** Fulfilment of the Company's legal obligations in relation to Services, provided that the processing of User data is necessary for this purpose.
- **Data processed for this purpose:** Identifying and contact data; Economic, financial and insurance data; Transactions of goods and services; Other categories of data; Data derived from the use of the service.
- **Lawful basis for processing:** Compliance with legal obligations.

## 7. Marketing communications:

- **Purpose:** The Company may send its own commercial communications to Users in order to promote the use of the Service and share content related to the Services.
- **Data processed for this purpose:** Identification and contact details.
- **Lawful basis for processing:** Legitimate interest of the Company to arouse interest and promote the purchase of our products and services and to enhance the image of the Company. ## 8. Third Parties Marketing Communications:

- **Purpose:** Based on the consent of the Users, the Company may send commercial communications from third parties to the Users, in order to promote products and/or services of third parties related to the following sectors of activity: manufacturing industry; electricity, gas, steam and air conditioning supply; wholesale and retail trade, repair of motor vehicles and motorbikes; transport and storage; hotel and catering; information and communications; financial and insurance activities; professional, scientific and technical activities; administrative and support service activities; health and social work activities; and artistic, recreational and entertainment activities.
- **Data processed for this purpose:** Identification and contact details.
- **Lawful basis for processing:** Consent of data subject.

## 9. Management of promotions:

- **Purpose:** Management of promotions and the participation of Users in them, including providing the User with information on the promotional activity in question and compliance with the Company's legal

obligations arising from the development of promotional activities.

- **Data processed for this purpose:** Identification and contact details; Data derived from the use of the service.
- **Lawful basis for processing:** Performance of established legal relationship.

#### 10. Geolocation:

- **Purpose:** In order to provide services, the Company may require the use of geolocation data of Users.
- **Data processed for this purpose:** Identifying and contact data; Other categories of data.
- **Lawful basis for processing:** Performance of contract.

#### 11. Fraud prevention:

- **Purpose:** Management and development of fraud prevention and control activities.
- **Data processed for this purpose:** Identifying and contact data; Social circumstances; Transactions of goods and services; Other categories of data; Data derived from the use of the service.
- **Lawful basis for processing:** Legitimate interest of the Company in not being a victim of fraud. #### 12. Processing and management of images collected in case of road accident.

- **Purpose:** In the event of traffic accidents, the vehicle's sensors may activate the cameras installed on the front of the vehicle to capture the images necessary to process any claims arising from the event. No sounds will be recorded, only twenty seconds of video will be captured, and these images will be managed to guarantee the legal protection of the Company.
- **Data processed for this purpose:** Data derived from the use of the vehicle -for the activation of the cameras-, license plates and images of stakeholders. The image of the interior of the vehicle and sounds will not be collected.
- **Lawful basis for processing:** Legitimate interest of the Controller in ensuring the effective legal protection of the Company. #### 13. Analysis of the user's driving and identification of high-risk events.

- **Purpose:** Identification of high-risk events that are collected through the devices installed in the vehicle to inform the user when dangerous situations are detected (such as short distance with the vehicle in front, high speed, large accelerations, braking and sharp turns), to warn the user of them by means of acoustic signals and/or voice messages. Hazardous events will be recorded in the Company's systems and, if applicable, may result in the charging of an additional fee and/or the blocking of the account of users who violate the terms of service.
- **Data processed for this purpose:** Data derived from the use of the vehicle and identification data.
- **Lawful basis for processing:** Legitimate interest of the Controller to ensure the safety of users and the security of property and vehicles. You may request further information about how we have assessed our

## From which sources does the personal data we process come?

The personal data processed by the Company as a result of interactions carried out by Users through the App come from the following sources:

- Personal data provided by Users through the forms made available by the Company.
- Personal data obtained as a result of the use of the Services by Users, including vehicle safety sensors.
- Subject to your consent, from external sources, that is, from entities that are not the Company.

## To whom are your personal data communicated?

The Company informs you that your data may be communicated to the following entities in accordance with the legitimate basis of the communication:

- For the purpose of the proper performance of the contractual relationship, we may communicate your data to:
  - Insurance companies, for the management of claims and/or accidents.
- In order to comply with applicable legal obligations, we may disclose your data to:
  - Tax Agency and other competent administrations, for the fulfilment of tax obligations.
  - Competent public administrations, for the identification of drivers in compliance with the applicable regulations.
  - Other public administrations and/or competent authorities, such as State Security Forces and Corps, to the extent necessary and/or as required by the applicable regulations.
- In order to fulfil our legitimate interests, for example, in the case of accident image recordings, we may disclose your data to:
  - Insurance companies, for the management of claims and/or accidents.
  - Other public administrations and/or competent authorities, such as State Security Forces and Corps, to the extent necessary and/or as required by the applicable regulations.
  - Courts and tribunals.
- On the basis of our legitimate interest in ensuring the continuation of our activities in the context of transfer or

other transactions, we could communicate your data to the following actors:

- acquirers, successors or assignees of our company in connection with a merger, acquisition, debt financing, sale of assets or similar transaction, or in the event of a collective proceeding during which information would be passed to one or more third parties among our business assets.

The Company is supported by various service providers who act under its responsibility and on behalf of ZITY as "data processors", such as Google Cloud. Likewise, the Company informs users that the personal data provided to us is stored in the European Economic Area. Notwithstanding the foregoing, if for the provision of any particular service, such as the management of payments through the payment gateway, an international transfer of data is necessary, the Company will cover such international transfer with one of the guarantees recognised under the applicable regulations, such as the signing of the standard contractual clauses approved by the European Commission. ## How long do we retain your personal data?

The personal data provided will be kept for the period of time determined on the basis of the following criteria: (i) duration of the legal relationship and attention to any liabilities arising from such relationship; (ii) legal obligation of retention; and (iii) request for deletion by the data subject in appropriate cases. ## What are your rights as data subject?

The User has the right to **access** their personal data and to obtain confirmation of how we're processing them, as well as to request the **rectification** of inaccurate data or, where appropriate, request its **erasure** when, among other reasons, the data is no longer necessary for the purposes of processing they were collected for.

Under certain circumstances, data subjects may request the **restriction** of the processing of their data, in which case we will only keep them for the exercise or defense of claims. The User can also **oppose** to the processing of data based on grounds relating to their particular situation, in which case we will stop processing the data, except for compelling legitimate reasons or for the exercise or defense of claims.

The User may request the right to the **portability of the data** and obtain for himself/herself or for another service provider certain information derived from the formalized relationship with the Company.

To exercise the data protection rights, or revoke the consents provided, the User can write to CAR SHARING AND MOBILITY SERVICES France, Customer Service, 22, rue Yves Kermen, Boulogne, 92100 (France), indicating as reference "Data

The Company informs the User that in order to make the right exercised effective, it may be necessary for the User to provide additional documentation to prove his/her identity (e.g. a copy of his/her national identity card or passport).
