- Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee. 13.

The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./ Department as required.

- In addition to above the Managing Committee shall abide by the provisions of Haryana School Education 14. Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
- School will provide ramp within six months. 15.
- If any information, at any stage found Contrary to the Fact's the recognition would be revoked 16. Forthwith.
