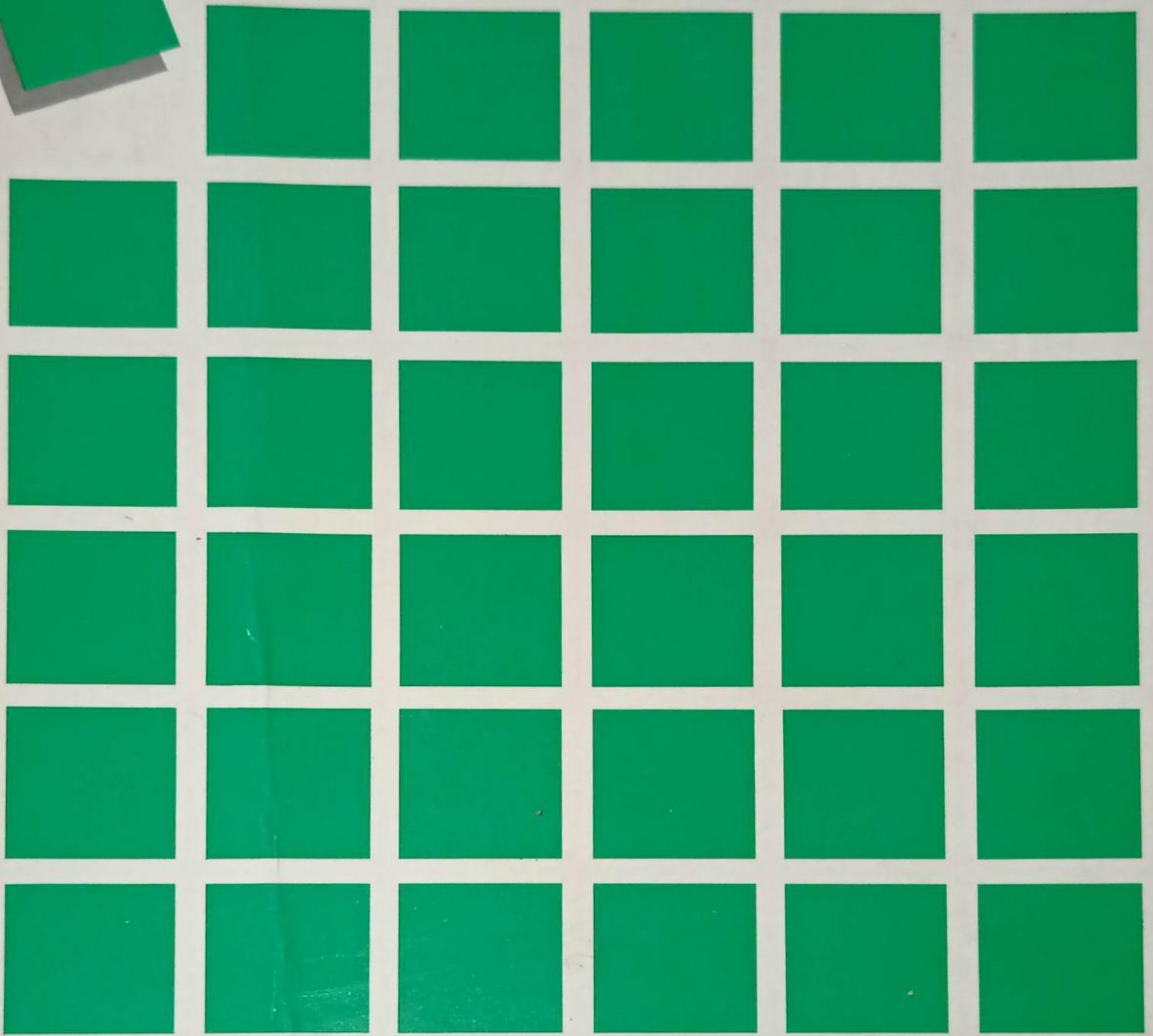
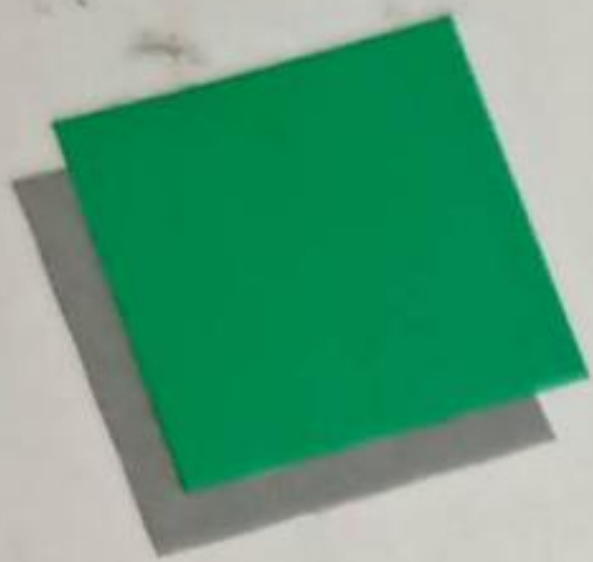

Proprietors' funds and the meaning of a share in a company. Private and public limited companies, 1980 Companies Act definitions: limitations on borrowing by debentures by a private limited company. Preference shares and Ordinary shares: the annual dividend expectations. Creation of reserves and the transfer of funds thereto. Self-examination questions and assignments. Issuing shares and debentures, journal entries: Share Premium Account, Total Shareholders' Interest and the capitalization of reserves; impact on the market value of shares. Self-examination questions and assignments. Preference shares and debentures compared. Calculation of percentage rate of dividends; earnings per (ordinary) share and share valuation. Gearing: a mixed package of long-term financing for companies. Issue of shares and debentures at a discount. Redemption of shares: 1981 Act provisions: accounting requirements. Capital employed, and capital invested: Balance Sheet entries. Valuation of fixed assets: revaluations and the revaluation reserve. The function of depreciation and its calculation: straight line and reducing balance methods of depreciation, and the relevant accounting records. Companies Act requirements for disclosures of assets in Balance Sheets. Sum of the digits method of depreciation. Self-examination questions and assignments. Valuation of raw material stocks and the impact of price changes: effect of stock valuations upon a firm's total current assets sum, on working capital and capital employed book values. Methods of valuation: FIFO, LIFO, average price and weighted average price. Stock records. Valuations of work in progress and finished goods: the question of overhead costs and their apportionment in stocks valuations: the requirements of the 1981 Companies Act and the Accounting Standards Committee compared. Comparison of contribution with profit/volume ratios: the value of P/V ratios in a multiproduct firm. Comparative studies of contribution and P/V ratios in relation to limiting factors of production and sales. Allocation of overhead costs to production areas: apportionment to products, criteria and
