The following provision is recommended regarding increase in the internal assessment from 10% to 20% in all Graduate and Post-Graduate courses where there is no provision of internal assessment, w.e.f. the session 2041-12. The House examination shall stand scrapped automatically:

For under Graduate courses he increased from 10% to 20% in each theory paper based on the following criteria:

 Two Handwritten Assignments (Ist Assignment after one month & Und Assignment after two months)

(ii) One Class Test (one period duration) in each semester: 5% One special chance may be given on medical grounds (Medical Certificate should be countersigned by CMG/SMO) and extra -certicular activities officially assigned

(iii) Attendance
Marks for Attendance will be given as under.

(1) 91% onwards: 5 marks
(2) 81% to 90% : 4 marks
(3) 75% to 80% : 3 marks
(4) 70% to 74% : 2 marks

(3) 65% to 69% 1 marks*

*For students engaged in extra-curricular activities in the Colleges/Departments of the University medical grounds (Medical Certificate should be countersigned by the CMO/SMO) approved by the concerned Principal/Chairperson.

In the M. A. courses also, where there is no provision of internal assessment, 20% marks will be carmarked for the internal assessment to be awarded on the above based criteria w.e.f. 2011-12. In M. Sc. and other courses wherein the provision of internal assessment of 20% or above is already in existence, the status-quo may be maintained and the above criteria may also be implemented.

3. Passing in internal assessment in each theory and practical paper is not mandatory. However, to pass in each theory paper, a candidate must obtain at least minimum pass marks in each theory paper separately. The candidate should also obtain minimum pass marks in the aggregate of internal assessment and written/practical paper.

4. In order to make system of internal assessment more compatible as well as to maintain uniformity the above criteria of internal assessment may also be implemented for all the old students of all courses in University Teaching Departments from the session 2011-12.
